

Survey for Dow Cameron Oil & Gas, LLC.

Being a part of land located in the State of Ohio, County of Muskingum, Township of Washington, part of Quarter Township 3, Township 1 North, Range 7 West, United States Military Lands, and part of the lands currently owned by Dow Cameron Oil and Gas, LLC. (OR 2237-34).

Commencing at the southwest corner of Lot 16 of Richard Dickson's Subdivision (Re-Plat Book 1, Page 200);

thence along the centerline of Coal Run Road (TR-241) North 40 degrees 26 minutes 51 seconds West 59.01 feet to a point, being the southeast corner of J.C. and R.C. Holdings, Inc. (DR 2763-70);

thence along the east line of J.C. and R.C. Holdings, Inc. (DR 2763-70) North 22 degrees 08 minutes 32 seconds East 28.41 feet to an iron pin found;

thence continuing along the east line of J.C. and R.C. Holdings, Inc. (DR 2763-70) North 22 degrees 08 minutes 32 seconds East 202.41 feet to an iron pin found, being the northeast corner of J.C. and R.C. Holdings, Inc. (DR 2763-70);

thence along the north line of J.C. and R.C. Holdings, Inc. (DR 2763-70) the following two courses:

1. North 63 degrees 01 minutes 56 seconds West 2.77 feet to a point;
2. North 69 degrees 19 minutes 04 seconds West 77.67 feet to a point on the east right-of-way of relocated Adamsville Road (CR 694);

thence along the east right-of-way of relocated Adamsville Road (CR 694), the following three courses;

1. On a curve to the right having a radius of 2626.26 feet, a central angle of 01 degrees 47 minutes 50 seconds and a chord bearing North 45 degrees 10 minutes 07 seconds East 82.38 feet to a point;
2. North 46 degrees 04 minutes 02 seconds East 183.10 feet to a point;
3. On a curve to the left having a radius of 724.50 feet, a central angle of 08 degrees 54 minutes 56 seconds and a chord bearing North 41 degrees 36 minutes 34 seconds East 112.62 feet to a point, the **place of beginning** for this parcel;

thence continuing on said right-of-way on a curve to the left having a radius of 724.50 feet, a central angle of 04 degrees 44 minutes 55 seconds and a chord bearing North 34 degrees 46 minutes 23 seconds East 60.03 feet to an iron pin set;

thence leaving the east right-of-way of Adamsville Road (CR 694) and through Dow Cameron Oil and Gas, LLC. (DR 2237-34) the following two courses:

1. South 57 degrees 15 minutes 21 seconds East 337.09 feet to an iron pin set;
2. South 24 degrees 46 minutes 30 seconds West 60.58 feet to an iron pin set on the north line of County of Muskingum, Ohio (DR 1851-284);
