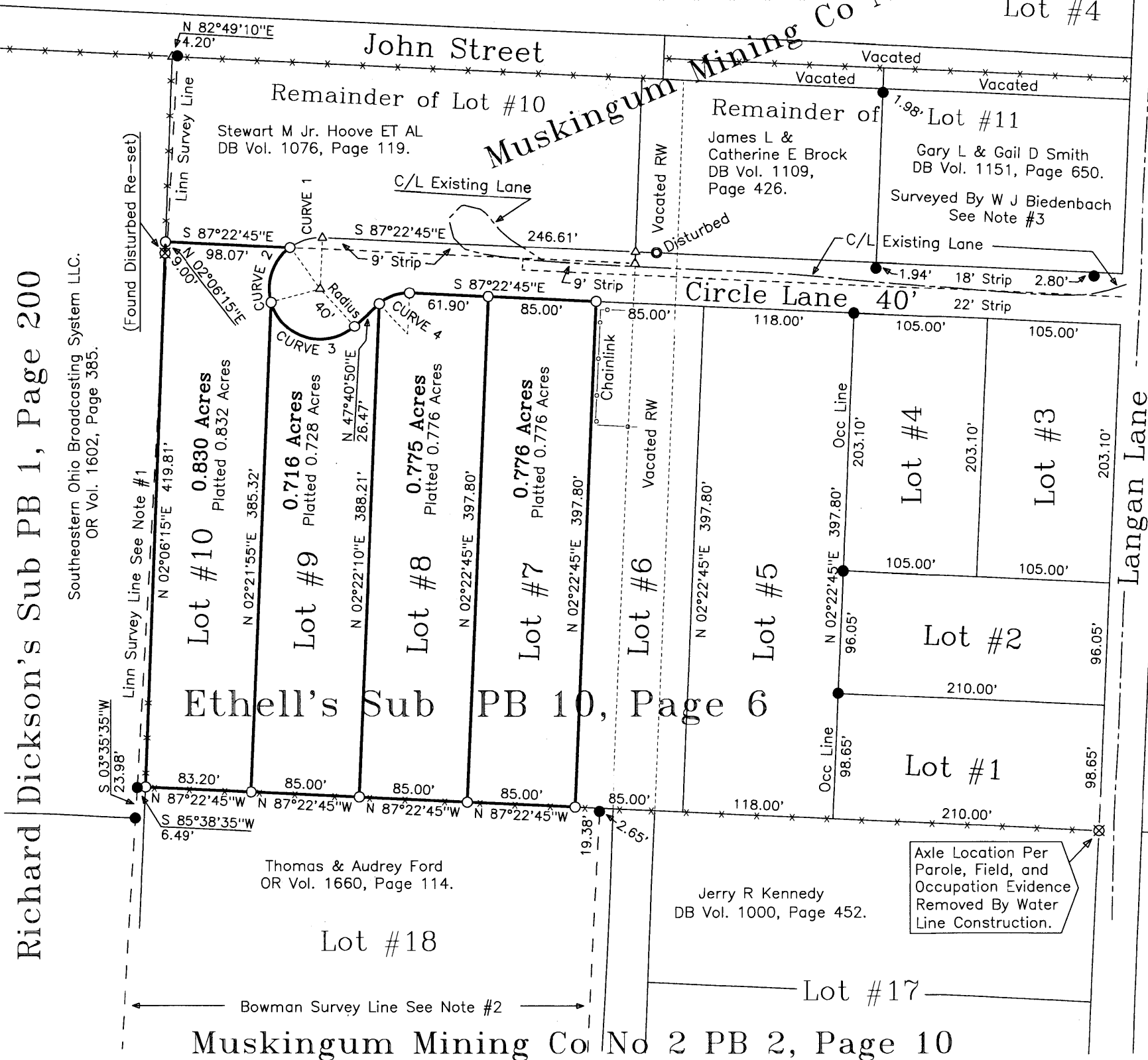


The bearings on this plat are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations.

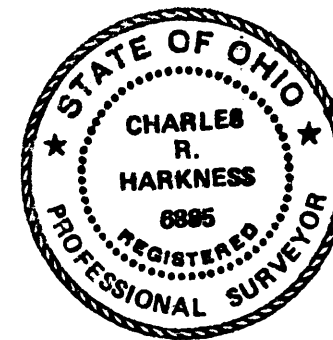

## SURVEYOR'S NOTES & REFERENCES:

Muskingum Co. Tax Maps and Orthophotos of the area. 3-D TopoQuads by DeLorme (Ohio).  
Note #1- Timothy Linn Survey overlaps the Northwest corner of Lot #10 by 1.45 feet, and has a hiatus of 6.43 feet at the Southwest corner of Lot #10.  
Note #2- Steven Bowman Survey has a hiatus of 0.82 feet at the Southwest corner of Lot #10 and 2.55 feet at the Southeast corner of lot #7.  
Note #3- W J Biedenbach Survey overlaps the Northern Right of way for Circle Lane as shown.  
Note #4- Parole evidence taken from George Ethell indicated the original subdivision owner (George's Father) Floyd Ethell replaced the wood stakes set by H C Weigelt with iron pins. Some of those pins, two original 1" Pin (Axles) and long term occupation lines were used to re-establish the Lot lines as shown. The geometric shape of the platted subdivision fits extremely well, no long term occupation of used monument was found out of alignment or position by more than 0.2 feet.  
Note #5- Conflicts with external lines of the subdivision with recent surveys may alter those lines, however no adjustment of the eternal subdivision lines would be necessary or advisable.
