- 3) North 22 degrees 48 minutes 40 seconds East 50.00 feet to an iron pin set,
- 4) North 75 degrees 28 minutes 42 seconds East 50.00 feet to an iron pin set,

thence; along the west line of Jeffery L. Hill, Deedbook 2142, Page 173, South 38 degrees 49 minutes 25 seconds East 23.16 feet to a point in the creek,

thence; along the north line of D. & M. Kennedy, Deedbook 929, Page 181, South 75 degrees 28 minutes 42 seconds West 64.99 feet to an iron pin set,

thence; along the east line of D. & M. Kennedy, Deedbook 929, Page 181, South 12 degrees 33 minutes 51 seconds East 89.96 feet to an iron pin set,
