Charlotte Ann Sharp OR 2189-278 +/- 4.840 Acres

Situated in the State of Ohio, County of Muskingum, Township of Washington, being part of the 3rd Quarter Township, Township 1, Range 7 and being all of the land now owned by Charlotte Ann Sharp as recorded in OR 2189-278 of the Muskingum County Recorders Office and more fully described as follows.

Beginning for reference at the southwest corner of Lot 3, John C. Howards Sub. (DR 9-394) and going South 54 degrees 26 minutes 34 seconds West, 374.61 feet to an iron pin found on the south side of Wedgewood Drive and on the northwest corner of the lands now owned by Barbara L. Dailey (DR 1146-774) and and the principal place of beginning;

thence with the the common line of said Sharp & Dailey's lands the following two (2) courses:

- 1. South 02 degrees 23 minutes 13 seconds West, 238.66 feet to a pipe found;
- South 89 degrees 41 minutes 49 seconds East, 90.81 feet to an iron pin set on the northwest corner
 of the lands now owned by Larzelere Real Estate Company, Ltd. (OR 1956-566);

thence with the west line of said Larzelere Real Estate's lands, South 01 degrees 35 minutes 13 seconds West, 349.13 feet to a point on the northeasterly corner of the lands now owned by Westwood Baptist Church, Inc. (OR 2487-258), said point is referenced by an iron pin set which bears, South 02 degrees 22 minutes 00 seconds West, 233.52 feet;

thence with the common line of said Sharp & Westwood Baptist Church's lands, South 62 degrees 25 minutes 17 seconds West, 451.48 feet to a point which lies in the west bound lane of Interstate 70, said point is referenced by an iron pin set which bears, South 01 degrees 26 minutes 54 seconds West, 53.86 feet;

thence with the west line of said Sharp's lands, North 01 degrees 26 minutes 54 seconds East, 560.29 feet to a pipe found on the south line of the land now owned by Paul A. Zemba & Frances K. Zemba (DR 994-351);

thence with the common line of said Sharp and Zemba's lands the following two (2) courses:

- 1. South 89 degrees 41 minutes 49 seconds East, 173.39 feet to an iron pin set;
- North 02 degrees 23 minutes 13 seconds East, 236.11 feet to an axle found on the south line of said Wedgewood Drive;

thence with the south line of said Wedgewood Drive, North 89 degrees 11 minutes 47 seconds East, 131.62 feet to the place of beginning, containing 4.840 acres more or less, where 0.716 acres lies in Muskingum County Parcel 70-48-03-12-000 and 4.124 acres lies in Muskingum County Parcel 70-48-03-13-000 (0.913 acres of the 4.124 acres lies within the right of way of I-70) subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 4.840 acre parcel is based on a field survey made by Brian K. McPeek, PS 8517 of McPeek Land Surveying, LLC on July 28th, 2015.
