

Being a part of the 3rd Quarter of Township One, Range Seven, bounded and described as follows:

Commencing at a point marked by an existing stone at the Southwest Corner of Lot Number 3 of John C. Howard's Subdivision as recorded in Deed Book 9, Page 394 of the Muskingum County Deed Records; thence South 02 degrees 28 minutes 32 seconds East a distance of 1284.91 feet to a iron pin; thence North 81 degrees 03 minutes 01 seconds West a distance of 210.68 feet along the South limited access right-of way line to a point marked by an existing iron pin; thence South 02 degrees 12 minutes 48 seconds East a distance of 327.46 feet to a point marked by an existing wood post; thence North 87 degrees 31 minutes 28 seconds East a distance of 54.00 feet to a point marked by an existing iron pin; thence South 03 degrees 04 minutes 34 seconds East a distance of 396.46 feet to a point in the center of United States Route 40; thence South 60 degrees 55 minutes 45 seconds West a distance of 25.32 feet along the said center of United States Route 40 to a point; thence North 02 degrees 31 minutes 23 seconds West a distance of 106.45 feet to a point marked by an existing iron pin; thence North 65 degrees 09 minutes 09 seconds West a distance of 125.10 feet to a point marked by an existing iron pin; thence South 82 degrees 25 minutes 35 seconds West a distance of 233.07 feet to a point marked by an existing iron pin; thence North 71 degrees 14 minutes 35 seconds West a distance of 120.97 feet to a point marked by an existing iron pin; thence south 72 degrees 29 minutes 02 seconds west 75.11 feet to an iron pin found and the true place of beginning of the premises herein intended to be described; thence south 0 degrees 41 minutes 44 seconds East 154.87 feet to an iron pin; thence South 5 degrees 38 minutes 06 seconds East 158.31 feet to an iron pin on the North right-of-way line of State Route #40; thence South 3 degrees 11 minutes 34 seconds East 40.86 feet to a point in the center of State Route #40; thence along the center of said road South 75 degrees 01 minutes 28 seconds West 92.23 feet to a point; thence North 2 degrees 52 minutes 44 seconds West 350.13 feet to an iron pin found; thence North 72 degrees 32 minutes 47 seconds East 91.18 feet to the true place of beginning, containing seventy hundredths (0.70) of an acre more or less.



