Situated in Quarter Township #3, T-1-N, R-7-W, Washington Township, Muskingum County, Ohio. Being The lands of George Ferguson as conveyed in deed book 615 page 93 of the Muskingum County deed records and being described as follows:

Commencing at an axle found marking the Northeast corner of lot #14 of the Eastlynd Acres Subdivision (P.B. 10 Pg. 13); thence, S.78°45'00"W. a distance of 109.84 feet along the North line of said Subdivision to a point, referenced by an axle found bearing N.11°45'00"W. at 0.43 feet, **BEING THE POINT OF BEGINNING;**

thence, S.78°45'00"W. a distance of 119.00 feet along the North line of said Subdivision to a set iron pipe on the Southeast corner of the lands, now or formerly, owned by W. Herron (571/804);

thence, N.11°15'00"W. a distance of 300.00 feet along the East line of said Herron lands to a set iron pipe on the South line of U.S. Route #40;

thence, N.70°45'00"E. a distance of 119.00 feet along the South line of said Route to a set iron pipe on the Northwest corner of the lands, now or formerly, owned by H. Robinson (669/056);

thence, S.11°15'00"E. a distance of 300.00 feet along the west line of said Robinson lands to the point of beginning.

The above described parcel contains 0.820 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based upon an assumed meridian.




