BEING A PART OF THE 80.62 ACRES CONVEYED TO GREENLAWN ESTATES, LLC (DEED VOLUME 2047, PAGE 379 OF THE MUSKINGUM COUNTY DEED RECORDS), SITUATED IN QUARTER TOWNSHIP 3, TOWNSHIP 1, RANGE 7, OF THE UNITED STATES MILITARY LANDS, WASHINGTON TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING CONCRETE MONUMENT AT THE NORTHEAST CORNER OF LOT 53 OF THE WILLIAM BATEMAN ADDITION (PLAT BOOK 5, PAGE 74);

THENCE WITH THE WEST LINE OF EASTLYND ACRES (PLAT BOOK 10, PAGE 13), SOUTH 16 DEGREES 56 MINUTES 06 SECONDS EAST 802.28 FEET TO AN EXISTING ANGLE IRON;

THENCE CONTINUING WITH THE SAID WEST LINE AND THE WEST LINE OF EASTLYND ACRES NO. 2 (PLAT BOOK 10, PAGE 45), SOUTH 17 DEGREES 37 MINUTES 36 SECONDS EAST 657.25 FEET TO AN EXISTING CONCRETE MONUMENT;

THENCE WITH THE WESTERLY LINE OF EASTLYND ACRES NO. 4 (PLAT BOOK 11, PAGE 25) THE FOLLOWING TWO BEARINGS AND DISTANCES:

1. SOUTH 88 DEGREES 37 MINUTES 24 SECONDS WEST 4.62 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
2. SOUTH 37 DEGREES 38 MINUTES 14 SECONDS WEST 268.47 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING FOR THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID WESTERLY LINE OF EASTLYND ACRES NO. 4, SOUTH 37 DEGREES 38 MINUTES 14 SECONDS WEST 150.11 FEET TO AN EXISTING CONCRETE MONUMENT;

THENCE TRAVERSING INTO THE SAID GREENLAWN ESTATES TRACT THE FOLLOWING THREE BEARINGS AND DISTANCES:

1. NORTH 64 DEGREES 46 MINUTES 10 SECONDS WEST 216.69 FEET TO A POINT, PASSING AN IRON PIN SET AT 206.37 FEET;
2. NORTH 27 DEGREES 58 MINUTES 50 SECONDS EAST 199.49 FEET TO AN IRON PIN SET;
3. SOUTH 52 DEGREES 21 MINUTES 46 SECONDS EAST 245.10 FEET TO THE PLACE OF BEGINNING;

CONTAINING 0.918 MORE OR LESS ACRES, SUBJECT TO ALL APPLICABLE EASEMENTS.

NOT TO BE USED AS A SEPARATE BUILDING SITE OR TRANSFERRED AS AN INDEPENDENT PARCEL IN THE FUTURE WITHOUT PLANNING COMMISSION APPROVAL IN ACCORDANCE WITH APPLICABLE SUBDIVISION REGULATIONS.
