

Being a part of the North Half of the Northeast Quarter of Quarter of Quarter Township four, Township one, Range seven, of the United States Military Lands, Washington Township, Muskingum County, Ohio and being further described as follows:

Commencing at an existing iron pin (axle) at the Northwest corner of Lot number 18 of Rolling Hills Subdivision as recorded in Plat Book nine at page nineteen of the Muskingum County Plat Records; thence North 129.70 feet to a point; thence West 90.67 feet to a point marked by an iron pin, said point being the place of beginning of this tract; thence continuing West 113.70 feet to a point marked by an iron pin; thence North 00 degrees 35 minutes 44 seconds East 195.27 feet to a point marked by an iron pin; thence South 84 degrees 38 minutes 16 seconds East 107.00 feet to a point marked by an iron pin; thence South 01 degree 36 minutes 10 seconds East 183.33 feet to the place of beginning.

Commencing at the Northwest corner of Lot number twenty-eight of Rolling Hills Subdivision as recorded in Plat Book nine at page nineteen of the Muskingum County Plat Records; thence North 18.11 feet to a point; thence West 60.67 feet to a point marked by an iron pin; thence North 81 degree 36 minutes 16 seconds West 165.33 feet to a point, said point being the place of beginning of this easement; thence North 84 degrees 33 minutes 18 seconds West 107.00 feet to a point; thence North 00 degrees 35 minutes 44 seconds East 30.67 feet to a point; thence South 81 degrees 36 minutes 40 seconds East 113.31 feet to a point; thence North 89 degrees 35 minutes 40 seconds East 213.65 feet to a point; thence North 72 degrees 36 minutes 21 seconds East 118.00 feet to a point in the center of County Road number 141 (Jackson Road); said point being the Southeast corner of a 18.35 more or less acre tract recorded in Deed Volume 174 at page 167 of the Muskingum County Plat Records; thence South 43 degrees 17 minutes 27 seconds East 11.17 feet to a point in the center of County Road number 141 (Jackson Road); thence South 78 degrees 30 minutes 27 seconds West 143.14 feet to a point; thence South 80 degrees 38 minutes 40 seconds East 213.14 feet to a point; thence North 84 degrees 38 minutes 16 seconds West 17.17 feet to the place of beginning.
