

Being a part of Quarter Township 4, Township 1, Range 7, bounded and described as follows:

Commencing at an iron pin (axle) found at the northeast corner of the southeast quarter of Quarter Township 4; thence south 89 degrees 04 minutes 14 seconds west 2912.91 feet to the true place of beginning of the premises herein intended to be described; thence south 7 degrees 22 minutes 23 seconds east 47.32 feet to an iron pin; thence north 89 degrees 55 minutes 38 seconds west 27.30 feet to an iron pin; thence south 54 degrees 53 minutes 48 seconds west 40.0 feet to an iron pin; thence north 14 degrees 37 minutes 24 seconds west 100.0 feet to an iron pin on the south right of way line of State Route #40; thence along said right of way line north 66 degrees 56 minutes 39 seconds east 78.0 feet to an iron pin; thence south 7 degrees 22 minutes 23 seconds east 57.89 feet to the true place of beginning, containing sixteen hundredths (0.16) of an acre more or less.


