LEGAL DESCRIPTION FOR LELA BEATTY

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WASHINGTON, AND BEING PART OF QUARTER TOWNSHIP 4, TOWNSHIP 1, RANGE 7, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1086, PAGE 359 OF THE MUSKINGUM COUNTY DEED RECORDS. FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN FOUND AT THE NORTHWEST CORNER OF LOT #2 OF MOCKINGBIRD HILL SUBDIVISION, THE RE-PLAT RECORDED IN PLAT BOOK 15, PAGE 138, THENCE, ALONG THE EAST LINE OF MOCKINGBIRD HILL ROAD, NORTH 00 DEGREES - 22 MINUTES - 18 SECONDS WEST, 123.47 FEET TO AN IRON PIN FOUND; THENCE, ALONG THE NORTH LINE OF SAID ROAD, NORTH 89 DEGREES - 19 MINUTES - 53 SECONDS WEST, 184.38 FEET TO AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF THOSE LANDS RECORDED IN DEED VOLUME 832, PAGE 97, PASSING AN IRON PIN FOUND AT 48.95 FEET; THENCE, ALONG THE EAST LINE OF AFORESAID ROAD, NORTH 00 DEGREES - 18 MINUTES - 39 SECONDS WEST, 173.13 FEET TO AN IRON PIN SET AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, CONTINUING NORTH 00 DEGREES - 18 MINUTES - 39 SECONDS WEST, 137.72 FEET TO AN IRON PIPE FOUND AT THE SOUTHWEST CORNER OF THOSE LANDS DESCRIBED IN DEED VOLUME 702, PAGE 183; THENCE, SOUTH 77 DEGREES - 38 MINUTES - 39 SECONDS EAST, 318.04 FEET TO AN IRON PIN SET; THENCE, ALONG THE WESTERLY LINE OF THOSE LANDS RECORDED IN DEED VOLUME 936, PAGE 24, SOUTH 15 DEGREES - 25 MINUTES - 32 SECONDS EAST, 78.74 FEET TO AN IRON PIN SET; THENCE, NORTH 88 DEGREES - 55 MINUTES - 10 SECONDS WEST, 330.93 FEET TO THE POINT OF BEGINNING, PASSING AN IRON PIN SET AT 171.08 FEET, AND CONTAINING 0.777 ACRES MORE OR LESS.



