SAID CORNER BEING AT THE INTERSECTION OF THE LINE BETWEEN WASHINGTON  
AND WAYNE TOWNSHIPS AND THE CENTER OF TOWNSHIP ROAD NUMBER 193; THENCE  
FOLLOWING THE CENTER OF SAID TOWNSHIP ROAD NUMBER 193 THE NEXT FOUR  
COURSES AND DISTANCES:


