

DESCRIPTION OF SURVEY FOR CARTER E & DELORES C SHAFFER

Situated in the State of Ohio, County of Muskingum, City of Zanesville, Out Lot #21 in what was formerly the town of Putnam:

Being all of the property contained in the prior deed reference Vol. 756, Page 126, also being all of the Muskingum County Auditor's Parcel Number 80-81-19-03-14-000, and more particularly described as follows;

Commencing at the intersection of the West line of Woodlawn Ave. and the North line of Adams Street; thence along the West line of said Woodlawn Ave. N 0° 00' 00" W 84.83 feet to an iron pin (set) at the place of beginning for the property herein intended to be described; thence S 90° 00' 00" W 140.00 feet to an iron pin (set) on the East line of a 16.50 foot Alley; thence along the East line of said Alley N 0° 00' 00" W 40.00 feet to an iron pin (set); thence N 90° 00' 00" E 140.00 feet to an iron pin (found) on the West line of said Woodlawn Ave.; thence along the West line of said Woodlawn Ave. S 0° 00' 00" E 40.00 feet to the place of beginning containing 0.129 acres.

The bearings within this description are based on the assumed bearing of North along the West line of Woodlawn Ave.. Iron pins (set) are 5/8" rebar 34" in length with an aluminum identification caps (C R Harkness R S 6885).




