**LEGAL DESCRIPTION**

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being part of the southwest quarter of Section 4, Township 12, Range 13, and being all those lands intended to be described in Deed Volume 700, page 94; being further bounded and described as follows:

Commencing at the northwest corner of Lot #1 of Haugs Subdivision, as recorded in Plat Book 7, page 54, thence, north 05 degrees – 00 minutes – 00 seconds east, along the east line of White Oak Avenue, 134.36 feet to an iron pin found, and the **true point of beginning** for the parcel herein intended to be described:

**Thence**, continuing north 05 degrees – 00 minutes – 00 seconds east, 49.86 feet to a point;

**Thence**, leaving White Oak Avenue and along the southerly line of those lands now or formerly owned by K.E. Hayes (2228/337), south 85 degrees – 45 minutes – 13 seconds east, 302.06 feet to an iron pin found, passing an iron pin set at 2.00 feet;

**Thence**, south 05 degrees – 26 minutes – 19 seconds west, 49.86 feet, along the westerly line of those lands now or formerly owned by Paul Construction Company (2265/85), to an iron pin found;

**Thence**, north 85 degrees – 45 minutes – 20 seconds west, 301.67 feet, along the northerly line of those lands now or formerly owned by Stephanie Metcalf (1106/117), to the **point of beginning**, and **containing 0.345 acres more or less**.



