DEED DESCRIPTION

Situated in the State of Chio, County of Muskingum, being a resurvey of Marjorie Edwards V 440 P 29, being part of the Reserve Lot as shown on the Mylly Silliman's Addition to Zanesville in Plat Book "A " To "O " Page 151 in the City of Zanesville, and more particularly described as follows:

Beginning at a point at the Northwest Corner of Lot 15 of Mylly Silliman's Addition; thence South 86 Degrees 24 Minutes 56 Seconds West 16.51 feet to a 5/8 inch driller hole at the Northeast Corner of the Reserve Lot and the place of beginning; thence along the West line of Silliman Alley (16.50 feet R/W) South 01 Degrees 15 Minutes 33 Seconds East 86.82 feet to an iron pin set; thence North 89 Degrees 53 Minutes 14 Seconds West 36.00 feet to an iron pin set; thence North 01 Degrees 15 Minutes 33 Seconds West 84.50 feet to a 5/8 inch drilled hole on the South line of Greenwood Ave. (unknown R/W); thence North 86 Degrees 24 Minutes 56 Seconds East 36.02 feet to the place of beginning, containing 0.07 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the South line of Greenwood Ave. as being North 86 Degrees 24 Minutes 56 Seconds East.




