Being a part of Lot 41 and 42 of East Greenwood Terrace Addition as Recorded in Plat Book 4, Page 101 of the Muskingum County Plat Records and part of property now owned by Billy M. Smith and Recorded in Deed Book 820, Page 86 of the Deed Records in said County bounded and described as follows:



Beginning at an iron pin set on the south line of Lot 42, said pin bears north 85 degrees 19 minutes west 32.48 feet from the southeast corner of said Lot 42; thence north 85 degrees 19 minutes west ( the base of bearings for this description Plat Book 4, Page 101 ) along the south line of said Lot 42 and the south line of Lot 41 a distance of 19.50 feet to a point at the southeast corner of Ernest and Catherine Metz (Vol. 942, Pg.176 ) and passing through a point at the southwest corner of said Lot 42 and the southeast corner of said Lot 41 at 7.52 feet, thence north 5 degrees 01 minutes 54 seconds east along the east line of said Metz property 175.00 feet to an iron pin found on the south line of said Greenwood Ave and passing through an iron pin found at 1.10 feet; thence north 85 degrees 01 minutes 02 seconds east along the south line of said Greenwood Avenue 1.47 feet to a point, said point bears south 00 degrees 51 minutes 09 seconds east from a railroad spike set in the root of a Maple Tree; thence south 00 degrees 51 minutes 09 seconds east 176.06 feet to the place of beginning and passing from Lot 41 into Lot 42 at 104.70 feet containing fourty two thousands ( 0.042 ) of an acre more or less of which 0.006 of an acre is in Lot 42 and part of Auditors Tax Parcel No. 80-81-60-02-17 and 0.036 of an acre is in Lot 41 and is part of Auditors Tax Parcel No. 80-81-60-02-16.
