Situated in the State of Ohio, County of Muskingum, City of Zanesville, bounded and described as follows:

Commencing at the southwest corner of Lot 9 in Square 23 of the plat of Zanesville as recorded in Deed Book H, Page 241; thence crossing Marietta Street south 3 degrees 25 minutes 13 seconds west 49.50 feet to a point; thence along the south line of Marietta Street south 86 degrees 34 minutes 47 seconds east 16 feet to a railroad spike driven in the blacktop and being the true place of beginning of the premises herein intended to be described; thence continuing along the south line of Marietta Street south 86 degrees 34 minutes 47 seconds east 125.69 feet to Cypress Alley; thence along the west line of Cypress Alley south 3 degrees 25 minutes 13 seconds west 130.66 feet to a railroad spike driven on the north line of the canal properties; thence along the north line of said canal north 43 degrees 53 minutes 52 seconds west 5.67 feet to a 2 inch pipe set in concrete and designated as Monument No. 17 on a map drawn by United States Corps of Engineers in June 1935; thence along the southerly line of a 0.06 acre parcel conveyed to Arthur W. Schwoerer by deed recorded in Deed Book 283, Page 633, north 56 degrees 49 minutes 50 seconds west 139.97 feet to a drill hole set in concrete; thence along the west line of said 0.06 acre parcel and said line extended north 3 degrees 25 minutes 13 seconds east 57.36 feet to the true place of beginning, containing twenty-seven hundredths (0.27) of an acre more or less.

Subject to a flow-age easement to flood parts of the above parcel as described in Deed Book 283, Page 633.


