

DESCRIPTION OF SURVEY FOR PAMELA JEAN DUNN-UDDIN JOB#2777

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of Lot 31, of the Chancery Addition recorded in Deed Book "Q", Page 108, further **being all of** the Pamela Jean Dunn-Uddin property recorded in **Official Record Volume 2389, Page 61** of said county's deed records, further **being all of** Muskingum County **Auditor's Parcel Number 81-62-01-05-000**, and more particularly described as follows;

- Beginning at a survey nail (set) at the common corner for Lots 31 and 32 of said Chancery Addition, further being on the East line of Eighth Street;
- #1- **THENCE North 02 degrees 44 minutes 00 seconds East 33.00 feet** along Lot 31 and Eighth Street to the unmarked common corner of Lots 30 and 31 of said Chancery Addition, passing a survey nail (set) at 32.00 feet;
 - #2- **THENCE South 87 degrees 25 minutes 55 seconds East 10.00 feet** leaving Eighth Street and along the common line for said Lots 30 and 31, further being a common line for said Dunn-Uddin property and for the Sunrise TV Rentals, Inc. Property recorded in Official Record Volume 2150, Page 783 to a survey nail (set) at a corner of the Ernest B Graham property recorded in Deed Book Volume 318, Page 253;
 - #3- **THENCE South 02 degrees 34 minutes 05 seconds West 3.50 feet** into Lot 31 and along a common line for said Dunn-Uddin and Graham properties to an iron pin (set);
 - #4- **THENCE South 87 degrees 25 minutes 55 seconds East 18.50 feet** continuing along said properties to an iron pin (set);
 - #5- **THENCE North 02 degrees 34 minutes 05 seconds East 3.50 feet** continuing along said properties to a survey nail (set) on the common line for Lots 30 and 31;
 - #6- **THENCE South 87 degrees 25 minutes 55 seconds East 71.50 feet** along said Lot line and common line for said Dunn-Uddin and Sunrise TV Rentals, Inc. Properties to the unmarked common corner for Lots 30 and 31, further being on the West line of Darroway Alley;
 - #7- **THENCE South 02 degrees 44 minutes 00 seconds West 33.00 feet** along Lot 31 and said alley to a survey nail (set) at the common Eastern corner of Lots 31 and 32, passing a cotton gin spike (set) at 1.00 feet;
 - #8- **THENCE North 87 degrees 25 minutes 55 seconds West 100.00 feet** leaving said alley and along the common line for Lots 31 and 32, further being a common line for said Dunn-Uddin property and for the City of Zanesville property recorded in Official Record Volume 2833, Page 865 to the place of beginning, **containing 0.074 acres.**

The bearings and distances within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. See plat for META Data. Iron pins(set) are 5/8" rebar 30 inches long with identification caps (C.R.Harkness P.L.S.6885).
