ALL OF AUDITORS PARCEL
81-63-01-19-000 (0.098 Acres)

Situated in Lot 3 of Green's East Side Addition, City of Zanesville, Muskingum County, Ohio. Being the lands of Vincent and Lola Durant as conveyed in Deed Book 534 Page 862 of the Muskingum County Deed records and being described as follows:

Beginning at a set rebar in the Northwest corner of Lot 3 of Green's East Side Addition (D.B. "B" Pg. 284);

Thence, **S.89°56'03"E.** a distance of **33.01** feet along the South line of Fountain Square to a set rebar on the Northwest corner of the lands, now or formerly, owned by V. Kinder (1020/151);

Thence, **S.00°18'23"W.** a distance of **129.26** feet along the west line of said Kinder lands to a set rebar on the North line of a 14' alley (Peters Alley);

Thence, **S.89°00'20"W.** a distance of **33.01** feet along said Alley to a Point on the East line of a 16' Alley;

Thence, **N.00°18'22"E.** a distance of **129.87** feet said Alley to the Point of Beginning.

The above described parcel contains 0.098 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. 

SITUATED IN LOT 3 IN GREEN'S EAST SIDE ADDITION, CITY OF ZANESVILLE,
