

DESCRIPTION OF SURVEY FOR ARLINGTON HOTEL INC. JOB#501

Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being part of Lot #13 in Square Number 24 in the McIntire's East Addition to the City of Zanesville, recorded in Deed Book "B", Page 284, as described in the prior deed reference Volume 1055, Page 587 of said county's deed records, also being all of Muskingum County Auditor's Parcel Number 80-81-63-04-02-000, and more particularly described as follows;

- #1- Beginning at the Northeast corner of said Lot #13; thence S 00 04 46 W 189.90 feet along the common line for said Lot #13 and Lot #14 also of said Subdivision and Block to the Southeast corner of Lot #13 also being on the North line of the E Achauer property as described in deed reference 567, Page 112;
- #2- thence S 90 00 00 W 50.00 feet along the South line of said Lot #13 also being the North line of said Achauer property to the East side of the extension of Van Buren Alley as set aside in prior deed reference Volume 32, Page 574;
- #3- thence N 00 04 46 E 189.90 feet along the East side of said alley extension to the South line of Main Street and North line of said Lot #13 from which the Northwest corner of said Lot #13 and 4 foot exception described in deed reference Volume "N", Page 100 bears for reference N 90 00 00 W 16.00 feet;
- #4- thence N 90 00 00 E 50.00 feet along the South line of Main Street and North line of Lot #13 to the place of beginning containing 0.218 acres.

The bearings within the description are based on the South line of Main Street being an assumed bearing of N 90 00 00 E. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).






Notes -
