
DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, First Ward of the City of Zanesville, bounded and described as follows:

Beginning at an iron pin set at the ~~southwest~~<sup>west</sup> corner of Lot 16 in Square 8 of the Town of Zanesville as the same is designated and delineated in Deed Book "E", Page 444, said corner being the intersection of the north line of South Street and the east line of Potter Alley (16.5 feet wide), thence along the east line of Potter Alley North 00 degrees 05 minutes 36 seconds East 68.98 feet to a railroad spike set on the north line of said Lot 16; thence along said north line South 90 degrees 00 minutes 00 seconds East 63.38 feet to a PK nail set on the west line of Harvey's Road as described in Deed Book "B", Page 252; thence along the west line of said road South 30 degrees 10 minutes 08 seconds East 79.78 feet to an iron pin set on the north line of South Street; thence North 90 degrees 00 minutes 00 seconds West 103.59 feet to the place of beginning, containing 0.132 acre, more or less, subject to all legal road right of ways and applicable easements, written or implied.

Bearings are based on the north line of South Street as North 90 degrees 00 minutes 00 seconds East.

This description is written based on a survey completed March 09, 1990 by Timothy H. Linn, Reg. No. 7113.


