**LEGAL DESCRIPTION  
DELORIS DUNN PROPERTY**

Situated in the State of Ohio, County of Muskingum, City of Zanesville, and being part of the northeast quarter of Section 13, Township 16, Range 14, and being all of Lot #3 of an unrecorded plat of the lands of William N. Merrick, and being all those lands intended to be described in Deed Volume 1148, page 288; being further bounded and described as follows:

Commencing at the intersection of the south line of Merrick Avenue and the west line of Maysville Avenue (U.S. Route 22), said point also being the northeasterly corner of Lot #1 of aforesaid William N. Merrick lands, thence, South 30 degrees - 44 minutes - 30 seconds West, 136.11 feet along the west line of said Maysville Avenue to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

THENCE, South 33 degrees - 26 minutes - 20 seconds West, 45.65 feet to a point on the south line of said Lot #3 and on the west right-of-way line of said U.S. Route 22, as recorded in Deed Volume 607, page 53;

THENCE, North 65 degrees - 17 minutes - 20 seconds West, 106.64 feet to a point on the easterly line of a sixteen (16) foot alley;

THENCE, North 30 degrees - 44 minutes - 30 seconds East, 45.37 feet to an iron pin found;

THENCE, South 65 degrees - 17 minutes - 20 seconds East, 108.80 feet to the *point of beginning*, and containing 0.1116 acres more or less.

Subject to all legal highways and easements of record, whether recorded or implied.

Bearings described herein are based upon the north line of Maysville Avenue, as South 30 degrees - 44 minutes - 30 seconds West.




