THENCE CONTINUING WITH THE NORTH LINE OF MERRICK AVENUE, NORTH 86 DEGREES 58 MINUTES 40 SECONDS WEST 100.00 FEET TO A POINT AT THE SOUTHEAST CORNER OF A PARCEL CONVEYED TO AMY GRANT AND JESSE ROBINSON IN O.R. VOLUME 2398, PAGE 245, PASSING AN IRON PIN SET AT 97.25 FEET;
