Beginning for reference at a limestone with an "X" found at the northwest corner of Lot 12 of Self's Subdivision (PB 7, Pg. 34) also being on the south line of Eppley Avenue, thence with the south line of said Eppley Avenue, North 86 degrees 59 minutes 57 seconds West, 85.05 feet to a concrete monument found on the northwest corner of the lands now owned by James D. & Tammy M. Williams (OR 1547-302) and the point of beginning;
thence with the west line of said Williams lands, South 03 degrees 05 minutes 48 seconds West, 138.62 feet to a concrete monument found on the north line of the lands now owned by Connie M. Flood (DR 720-331), passing the common line of Lot 4 & Lot 5 of Patty Tupper's Sub (PB "O", Pg. 515) at 100.00 feet;
thence with the north line of said Connie M. Flood and then the north line of the lands of Majorie Moorehead (DR 1046-296), North 86 degrees 50 minutes 22 seconds West, 55.93 feet to an iron pipe found on the common corner of said Moorehead's lands, Betty A. Mendenhall's lands (DR 975-343) and the lands now owned by George Sheppard (OR 2029-26);
thence with the east line of said Sheppard's lands, North 03 degrees 03 minutes 06 seconds East, 138.46 feet to an iron pipe found on the south line of said Eppley Avenue, passing the common line of said Lot 4 & Lot 5 at 38.46 feet;
thence with the south line of said Eppley Avenue, South 86 degrees 59 minutes 57 seconds East, 56.04 feet to the point of beginning, containing a total of 0.178 acres more or less, subject to all legal highways and easements of record.




