Situated in the State of Ohio, County of Muskingum, City of Zanesville:

Being all of the First and Second Parcels of the prior deed reference Volume 600, Page 152, of said county's deed records said First Parcel containing part of Lot #2 of John D. Imlay's Subdivision recorded in Plat Book 4, Page 150 of said county's plat records, also being all of Muskingum County Auditor's Parcel Number 80-82-30-03-28-000, and more particularly described as follows;

- Beginning at an iron pipe (found) at the Northwest corner of said Lot #2;
- #1- thence along and extending the North line of said Lot #2 S 84 41 00 E 113.00 feet to an iron pin (found) as described in deed reference Volume 834, Page 206, passing the Northeast corner of said Lot #2 at 40.00 feet, and the split between said First and Second Parcels at 80.00 feet;
- #2- thence parallel to the East line of North Superior Street S 05 08 00 W 50.00 feet to an iron pin (found) as described in said Volume 834, Page 206;
- #3- thence N 84 41 00 W 113.00 feet to an iron pin (set) on the East line of said North Superior Street, passing the split between said Second and First Parcels at 33.00 feet, and the East line of said Lot #2 at 73.00 feet;
- #4- thence along the East line of said North Superior Street N 05 08 00 E 50.00 feet to the place of beginning containing 0.130 acres.

The bearings within this description are based on monumentation (found) along the East line of North Superior Street as shown on the Plat of John D. Imlay's Subdivision as recorded in Plat Book 4, Page 150. Iron pin (set) is 5/8" rebar with aluminum identification caps (C.R.Harkness R.S.6885).



# SURVEY PLAT FOR MARTHA V. YERIAN
