Mortimer Volume 706, page 235 to a point in block wall; Thence South $89^{\circ}44'56''$ East along Lot 16 and M.M. Gassaway Volume 731, page 177, 52.57 feet to an iron pin set on the West line of Lot 14; Thence along Lots 16 and 17, M.M. Gassaway Volume 731, page 177, and K. Goins Volume 1127, page 749 North $00^{\circ}06'28''$ East 82.40 feet to an iron pin set; Thence South $89^{\circ}13'33''$ East along M. & T. Shepherd Volume 948, page 215, 40.00 feet to an iron pin set; Thence South $00^{\circ}06'24''$ West along Lot 13 and Mary M. Guy Volume 691, page 299, 123.06 feet to an iron pin set; Thence South $89^{\circ}59'23''$ West along Virginia Street, the South line of Lot 14 and part of Lot 15 92.69 feet to the place of beginning passing an iron pin found at 40.00 feet containing 0.164 Acres more or less.

Bearings are based on the North line of Virginia Street (Guyman Street) bearing North $89^{\circ}59'23''$ East.

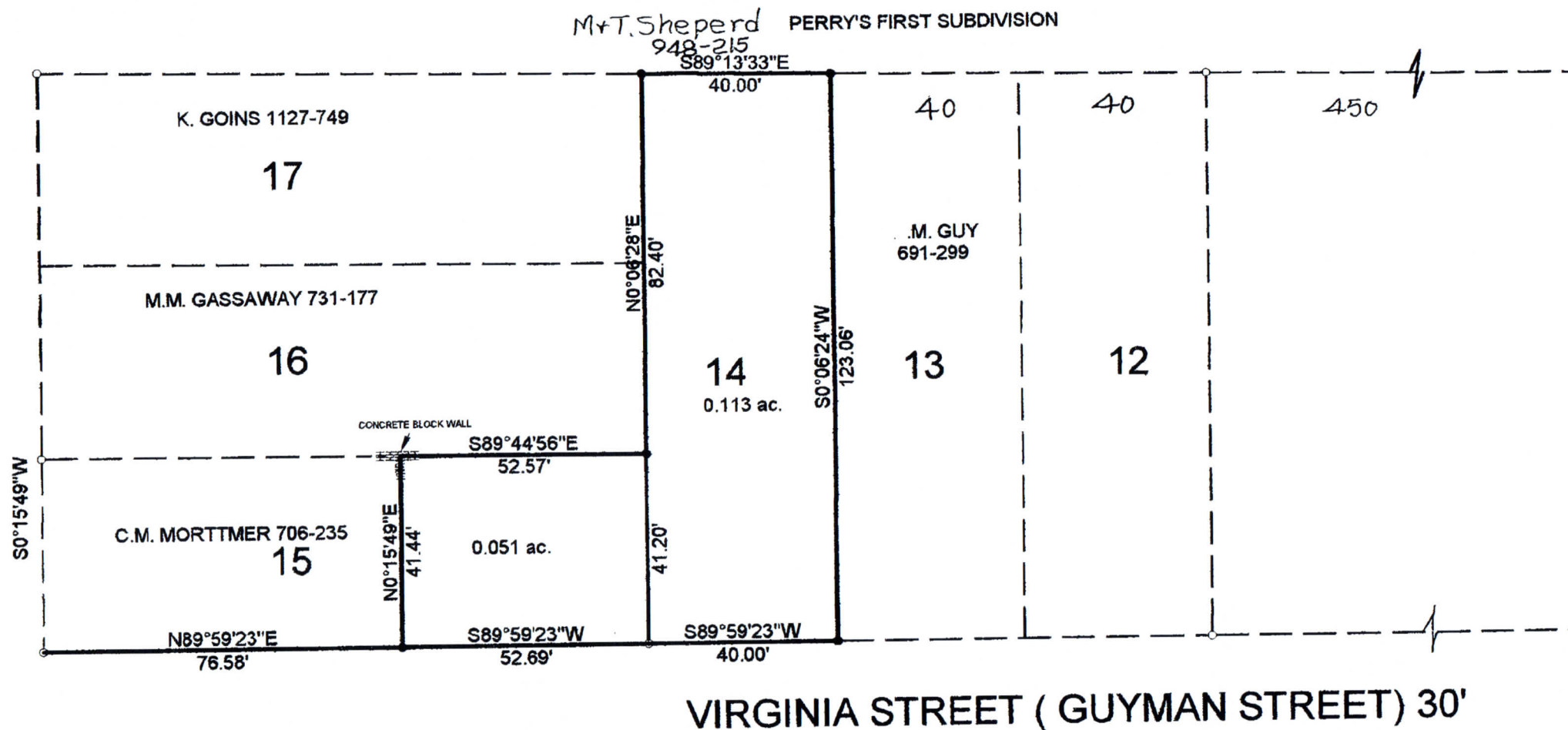
