

DESCRIPTION FOR CONVEYANCE

Premises at 1569 Ridge Avenue, Zanesville, Ohio 43701

First Parcel: 83-15-01-12 1569 RIDGE AVE

Situated in the County of Muskingum, in the State of Ohio, and in the City of Zanesville, and bounded and described as follows:

Being in the new Third Ward (1982), formerly the Seventh Ward, in said city, and being a part of an eight (8) acre tract of land conveyed to Mary A. Gray by Alva T. Wiles and wife by deed dated March 5, 1884, and recorded in Muskingum County Deed Records, Vol. 79, Pages 2 and 3, and being in the Northeast Quarter of the Southeast Quarter of Section 2, Township 16, Range 14 of the United States Military Lands in said county, and more particularly described as follows:

Commencing, for reference, at the Northeast corner of the Southeast Quarter of Section 2; thence running South along the Section line 722.70 feet, passing through an iron pin (rebar) set at 645.8 feet and an iron pin (rebar) set at 706.51 feet; thence South 81 degrees 18 minutes West 10.12 feet to an iron pin (rebar) set and being the True Place of Beginning of the premises herein intended to be conveyed; thence South 111.25 feet to an iron pin (rebar) set on the north line of Ridge Avenue; thence along the northerly line of Ridge Avenue the following two (2) courses;

- 1) South 58 degrees 35 minutes 15 seconds West 9.51 feet;
  - 2) South 52 degrees 35 minutes 45 seconds West 45.37 feet;
- thence North 09 degrees 16 minutes 11 seconds West 135.44 feet to an iron pipe found; thence North 81 degrees 18 minutes East 66.74 feet to the True Place of Beginning, containing 0.1596 acre, more or less, subject to all legal highways and easements of record.

Second Parcel: 83-15-01-13

Situated in the County of Muskingum, in the State of Ohio, and in the City of Zanesville, and bounded and described as follows:

Being in the new Third Ward (1982), formerly the Seventh Ward, in said city, and being a part of an eight (8) acre tract of land conveyed to Mary A. Gray by Alva T. Wiles and wife by deed dated March 5, 1884, and recorded in Muskingum County Deed Records, Vol. 79, Pages 2 and 3, and being in the Northeast Quarter of the Southeast Quarter of Section 2, Township 16, Range 14 of the United States Military Lands in said county, and more particularly described as follows:

Commencing, for reference, at the Northeast corner of the Southeast Quarter of said Section 2; thence running South along the Section line 645.8 feet to the True Place of Beginning of the premises herein intended to be conveyed; thence continuing South along the Section line 60.71 feet to an iron pin (rebar) set; thence South 81 degrees 18 minutes West along the northerly line of a right-of-way for ingress and egress 16 feet wide a distance of 84.78 feet to an iron pipe found; thence North 73.54 feet; thence East 83.81 feet to the True Place of Beginning, containing 0.1291 acre, more or less, subject to any easements of record.
