**DESCRIPTION FOR CONVEYANCE**  
Premises at 1543 Ridge Avenue, Zanesville, Ohio

Situated in the County of Muskingum, State of Ohio, and in the old Seventh Ward (now Third Ward) of the City of Zanesville, and bounded and described as follows:

Commencing, for reference, at an existing rebar located at the intersection of the Northerly line of Ridge Avenue with the Easterly line of Section 2, Township 16, Range 14, which rebar bears South 04 degrees 20 minutes 00 seconds West along the Section Line a deed distance of 828.95 feet from the Northeast corner of the Southeast Quarter of said Section 2; thence run North 62 degrees 12 minutes 00 seconds East along the Northerly line of Ridge Avenue a distance of 146.32 feet to the Place of Beginning of the premises herein intended to be described, said point being marked by a set iron pin (rebar); thence continue North 62 degrees 12 minutes 00 seconds East along the Northerly line of Ridge Avenue a distance of 77.50 feet to a point which bears South 62 degrees 12 minutes 00 seconds West 94.01 feet from an existing iron pipe at the intersection of the Westerly line of Corwin Avenue with the Northerly line of Ridge Avenue; thence run North 35 degrees 08 minutes 33 seconds West along the Westerly line of a 0.021 acre triangular strip of land conveyed to Roy Bartlett Wilson et ux from Ida M. Brown (Deed Book 268, Page 173), now owned by Jonathan S. Sims and Linda L. Sims (Deed Book 1097, Page 270), passing an iron pin (rebar) set at 5.00 feet, a total distance of 153.56 feet to an iron pin (rebar) set on the Southerly line of an alley 10 feet wide (an existing steel bar bears North 55 degrees 06 minutes 00 seconds East a distance of 11.84 feet); thence run South 55 degrees 06 minutes 00 seconds West along the southerly line of said alley a distance of 55.66 feet to an iron pin (rebar) set at the Northeasterly corner of lands heretofore conveyed to Charles A. Heslop (Deed Book 192, Page 22), now owned by Gladys Moore (Deed Book 682, Page 300); thence run South 26 degrees 45 minutes 34 seconds East, passing an iron pin (rebar) set at 140.45 feet, a total distance of 145.45 feet to the Place of beginning, containing 0.227 acre, more or less.


