new Third Ward (1983) in said city, and more particularly described as follows:


Beginning at an iron pin set at the most southerly corner of said Lot No. 2,
said point being at the intersection of the northerly line of Ridge Avenue
with the easterly line of Chapman Street; thence running North 39 degrees
30 minutes 30 seconds West along the easterly line of Chapman Street 86.00
feet to a point from which an existing iron pin (rebar) bears North 42 degrees
54 minutes 20 seconds West 0.47 feet; thence North 48 degrees 10 minutes
20 seconds East and along the southeasterly line of the premises now or
formerly owned by Harry Krouskouff (Deed Book 814, Page 64) a distance of
33.64 feet to an iron pin set; thence South 41 degrees 50 minutes 05 seconds
East and along the southwesterly line of the premises now or formerly owned
by Bobby Cleveland and Mattie Cleveland (Deed Book 773, Page 199) a distance
of 83.55 feet to an iron pin set on the northerly line of Ridge Avenue;
thence South 44 degrees 30 minutes 00 seconds West along said line 37.20 feet
to the place of beginning, containing 0.069 acre, more or less, and being
