

Being a part of Maple Wood Subdivision in the Eighth Ward (now the Fourth Ward) as recorded in Plat Book 2, Page 45 bounded and described as follows:


Beginning at the southwest corner of Lot 33 of said Maple Wood Subdivision; thence south 87 degrees east along the south line of Lot 33 a distance of 119 feet to a point; thence south 3 degrees west 66 feet to a point; thence south 87 degrees east 61.22 feet to a point; thence south 3 degrees west 57.89 feet to a point; thence south 87 degrees east 66.66 feet to a point; thence north 3 degrees east 123.89 feet to a point; thence south 87 degrees east 73.12 feet to the southeast corner of Lot 31 in said Maple Wood Subdivision; thence north 3 degrees east along the west line of Ashland Avenue 325 feet to the northeast corner of Lot 59 in Maple Wood Subdivision; thence along the south line of Forest Avenue north 87 degrees west 715 feet to the northwest corner of Lot 52 in said Maple Wood Subdivision; thence south 3 degrees west along the east line of Hazel Avenue 150 feet to a 15 foot alley; thence along the north line of said alley south 87 degrees east 265 feet to a point; thence crossing said alley south 3 degrees west 15 feet to a point; thence along the south side of said alley north 87 degrees west 265 feet to the east line of the aforesaid Hazel Avenue; thence along the east line of Hazel Avenue south 3 degrees west 160 feet to the southwest corner of Lot 37 in Maple Wood Subdivision; thence south 87 degrees east along the north line of Laurel Avenue 395 feet to the place of beginning, containing all of Lots 31, 32, 33, 34, 35, 36, 37, 52, 53, 54, 55, 56, 57, 58 and 59, a part of Lots 28, 29, and 30, a part of Laurel Avenue (now Vacated) a part of Myrtle Avenue (now Vacated) and a part of a vacated alley all in Maple Wood Subdivision.
