### TRACT 1

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF LOT #14 OF MOUNT AUBURN ADDITION, AS RECORDED IN PLAT BOOK 1, PAGES 74 AND 75, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1120, PAGE -74; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF SAID LOT #14, THENCE, NORTH 59 DEGREES - 57 MINUTES - 18 SECONDS WEST, 102.60 FEET TO A STONE FOUND ON THE WESTERLY SIDE OF AN ALLEY, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE, CONTINUING NORTH 59 DEGREES - 57 MINUTES - 18 SECONDS WEST, 209.86 FEET TO AN IRON PIN FOUND;

THENCE, NORTH 30 DEGREES - 36 MINUTES - 00 SECONDS EAST, 105.00 FEET TO AN IRON PIN SET;

THENCE, SOUTH 59 DEGREES - 56 MINUTES - 31 SECONDS EAST, 212.20 FEET TO AN IRON PIN SET ON THE WESTERLY LINE OF SAID ALLEY;

THENCE, SOUTH 31 DEGREES - 52 MINUTES - 30 SECONDS WEST, 105.00 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.5085 ACRES MORE OR LESS.
