

### Survey for E. Stewart

Being in the City of Zanesville, County of Muskingum, State of Ohio, and bounded and described as follows:

Beginning at an iron pin found at the northwest corner of Lot 24 of McIntire Terrace No. 1 ( Replat Book 1, Page 19), also being the northeast corner of E. and B. Heskett (OR 1136-494) and on the south line of Convers Ave.;

thence along the south line of Convers Ave. South 42 degrees 45 minutes 00 seconds East 164.84 feet to an iron pin set at the intersection of the south line of Convers Ave. and the west line of Findlay Ave.;

thence leaving the south line of Convers Ave. and along the west of Findlay Ave. South 38 degrees 35 minutes 16 seconds West 100.00 feet to an iron pin found at the northeast corner of R. and H. Buckley ( DR 1085-90);

thence leaving the west line of Findlay Ave. and along the north line of R. and H. Buckley (DR 1085-90) North 42 degrees 58 minutes 14 seconds West 170.06 feet to a point being the southeast corner of E. and B. Heskett (OR 1136-494), said point being referenced by an iron pin found being South 62 degrees 43 minutes 54 seconds West 1.17 feet from said point;

thence along the east line of E. and B. Heskett (OR 1136-494) North 41 degrees 36 minutes 02 seconds East 100.00 feet to the principle place of beginning, containing 0.38 acres, more or less.

Subject to all legal right-of-ways, easements, restrictions, zoning regulations either written or implied and any pertinent facts disclosed from a full and accurate title search including easements and right-of-ways.

The bearings for this survey are based on the north line of Lot 24 of McIntire Terrace No.1 (Replat Book 1, Page 19) and being South 42 degrees 45 minutes 00 seconds East. 
