### DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Falls, T-1, R-7, being a resurvey of David Eugene Durant vol. 532 page 234, being known as part of lot 54, in the McIntire Terrace #2 addition to the City of Zanesville and more particularly described as follows:

Beginning at a stone found with an "X" cut in the top at the Northeast corner of the parcel herein being described, said point also being 104.79 feet left of and radially of centerline station 936+ 00.17 (see State Route 60 plans Mus-60-16-88 sheet 19) said point also being on the west line of a 12 foot alley; thence following said line South 03 Degrees 08 Minutes 27 Seconds West 43.00 feet to a point; thence leaving said line North 86 Degrees 51 Minutes 33 Seconds West 110.25 feet to an iron pin set on the East line of Central Avenue; thence with said line North 03 Degrees 06 Minutes 05 Seconds East 43.00 feet to an iron pin set; thence leaving said line South 86 Degrees 51 Minutes 33 Seconds East 110.28 feet to the place of beginning containing 0.11 acres, more or less, subject to all legal highways and easements.

Subject to Central Avenue and a 12 foot alley R/W.

Iron pins set are 5/8 inch rebar with plastic identification caps.

Bearings are based on the East line of Central Avenue as being North 03 Degrees 06 Minutes 05 Seconds East.




