DEED DESCRIPTION

The following described Real Estate is situated in the State of Ohio, County of Muskingum, City of Zanesville and is bounded and described as follows:

Being part of Lot 11, Square One, Taylor's Second Addition to said City as the same is designated and delineated in Book 2, Page 4 of the Muskingum County Plat Records; beginning for reference at an iron pipe found on the southwest corner of Lot 9 Square Two of said Addition; thence South 0 degrees 00 minutes 17 seconds East (basis of bearings herein described) 155.62 feet to an iron pin set on the east line of Euclid Avenue (formerly Mechin Street) and the principal place of beginning; thence South 89 degrees 59 minutes 59 seconds East 127.00 feet to an iron pin set, passing an iron pin found at 63.61 feet; thence South 0 degrees 00 minutes 01 seconds West 55.00 feet to an iron pin set; thence North 89 degrees 59 minutes 59 seconds West 127.00 feet to an iron pin set; thence North 0 degrees 00 minutes 01 seconds East 55.00 feet to the principal place of beginning; as surveyed the tract contains 0.16 acres, more or less, subject to all legal highways and easements.

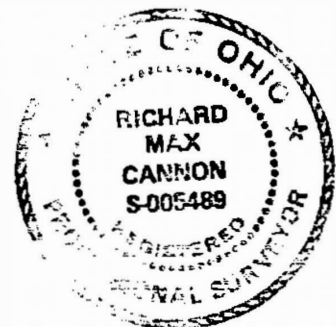

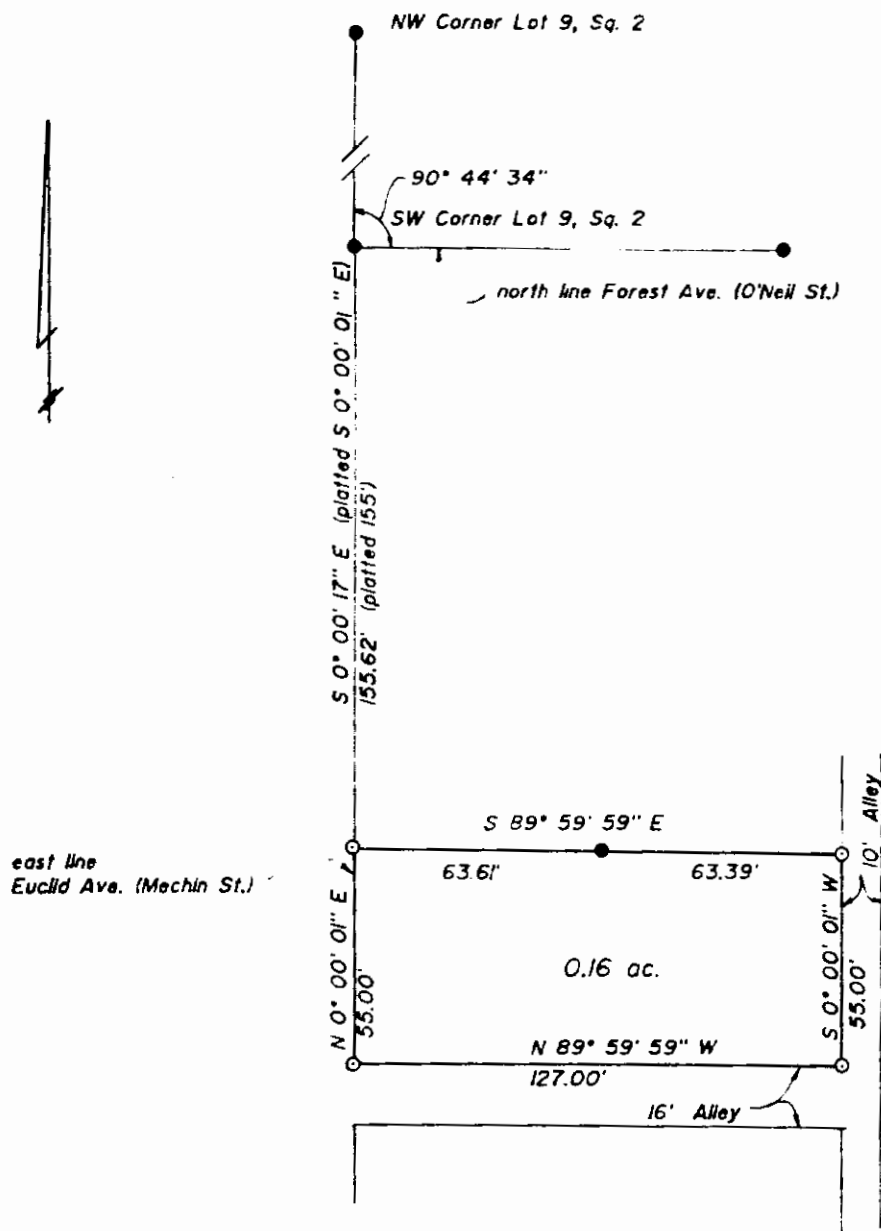
