COMMENCING AT THE NORTHEAST CORNER OF LOT NUMBER 20 OF WM. BLOCKSOM'S ADDITION AS RECORDED IN PLAT BOOK 1, PAGE 126 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE WITH THE SOUTH LINE OF MARKET STREET SOUTH 85 DEGREES 40 MINUTES 32 SECONDS EAST, PASSING EXISTING IRON PINS AT 101.00 FEET AND 170.00 FEET AND PASSING THE NORTHWEST CORNER OF LOT 25 AT 216.00 FEET, A TOTAL DISTANCE OF 252.93 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING WITH THE SOUTH LINE OF SAID MARKET STREET SOUTH 85 DEGREES 40 MINUTES 32 SECONDS EAST 28.00 FEET TO A DRILL HOLE IN A SIDEWALK; THENCE WITH A LINE MIDWAY BETWEEN TWO FOUNDATIONS SOUTH 02 DEGREES 07 MINUTES 51 SECONDS WEST 45.00 FEET TO A P-K NAIL SET IN A SIDEWALK; THENCE WITH A LINE PARALLEL TO THE SOUTH LINE OF SAID MARKET STREET NORTH 85 DEGREES 40 MINUTES 32 SECONDS WEST 29.72 FEET TO AN IRON PIN SET; THENCE NORTH 04 DEGREES 19 MINUTES 28 SECONDS EAST 44.97 FEET TO THE PLACE OF BEGINNING.




