PART OF AUDITORS PARCEL  
84-46-01-08-000 (0.269 Acres)

Situated in Quarter Township 3, T-1-N, R-7-W, U.S.M.L., City of Zanesville, Muskingum County, Ohio. Being part of the lands of Tina Bruce conveyed in Deed Book 1502 Page 389 of the Muskingum County Deed Records and being described as follows:

Commencing at the Northwest corner of lot 1 of Cox Addition (P.B. 1, Pg. 262); Thence, N.04°14'08"E. a record distance of 302.69 feet along the East line of Goddard Avenue to a point; Thence, N.67°54'54"W. a record distance of 167.61 feet along the Southwestern line of Goddard Avenue to a point; Thence, N.29°43'54"W. a record distance of 320.00 feet along said Avenue to a found rebar on the Southeast corner of the lands of T. Bruce (1502/389), BEING THE POINT OF BEGINNING;

Thence, S.60°22'13"W. a distance of **73.43** feet along said Bruce lands and along an un-named street to a set rebar;

Thence, N.36°05'03"W. a distance of **144.71** feet through said Bruce lands to a set rebar on the North line of said Bruce lands;

Thence, N.60°14'35"E. a distance of **89.55** feet along the North line of said Bruce lands to a found rebar on the Western line of Goddard Avenue;

Thence, S.29°41'23"E. a distance of **143.99** feet along Goddard Avenue to The point of beginning.

The above described parcel contains 0.269 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


