Situated in Lot 2 of Muskingum Mining Company's Second Addition, City of Zanesville, Muskingum County, Ohio.

Commencing at an axle found marking the Northwest corner of Lot 2 of the Muskingum Mining Company's Second Addition (P.B. 2, Pg. 10); thence, S.00°05'21"W. a distance of 64.00 feet along the West line of said lot to a point on the Southwest corner of the lands, now or formerly, owned by A. & A. Weaver (2127/638); thence, N.89°29'09"E. a distance of 181.82 feet along the South line of said Weaver lands to a point, BEING THE POINT OF BEGINNING, said point is referenced by a found axle located S.22°21'00"W. a distance of 0.14 feet;

Thence, **N.89°29'09"E.** a distance of **198.21** feet along the South line of Said Weaver lands to a set rebar on the West line of Neil Avenue;

Thence, **S.00°02'53"E.** a distance of **60.72** feet along the west line of Neil Avenue to a found iron pin on the Northeast corner of the lands, now or formerly, owned by j. Anslover, Et Al, (2121/583);

Thence, **S.89°29'09"W.** a distance of **198.85** feet along said Anslover lands to a set rebar on the East line of the lands, now or formerly, owned by J. & J. Spargrove (1138/053);

Thence, **N.00°33'45"E.** a distance of **60.72** feet along said Spargrove lands to the point of beginning.

The above described parcel contains 0.28 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.



**SURVEY PLAT FOR STEVEN PAISLEY**


