Being all of the First and Second Parcels as described in the prior deed reference Volume 572, Page 111, of said county's deed records, also being all of Muskingum County Auditor's Parcel Numbers 80-85-09-03-15-000, covering said First Parcel and 80-85-09-03-16-000 covering said Second Parcel and more particularly described as follows;

- Commencing at the intersection of the West line of Maple Avenue and the South line of Fairmont Avenue as existed prior to the widening of Maple Avenue as described in deed reference Volume 696, Page 208 of said county's records; thence along the South line of Fairmont Avenue (by deed) S 89 35 22 W 165.00 feet to an axle (found) at the place of beginning for the property herein intended to be described
- #1- thence along the West line of the property described in deed reference Volume 566, Page 392 S 00 42 39 E 54.83 feet to an axle (found in the top of a concrete wall), on the North line of the property described in deed reference Volume 1036, Page 355;
  - #2- thence along the North line of said Volume 1036, Page 355 and parallel to the South line of Fairmont Avenue S 89 35 22 W 20.00 feet to a 1/2" drill hole (set in the top of a concrete wall), at the Northwest corner of said Volume 1036, Page 355;
  - #3- thence along the West line of said Volume 1036, Page 355, and the property described in deed reference Volume 915, Page 109 also parallel to the West line of Maple Avenue S 00 00 00 W 87.19 feet to an axle (found) on the North line of a 16 foot wide alley;
  - #4- thence along the North line of said alley S 89 55 23 W 138.44 feet to an axle (found) at the Southeast corner of the property described in deed reference Volume 918, Page 324;
  - #5- thence along the East line of said Volume 918, Page 324 N 00 03 28 W 141.21 feet to an axle (found) on the South line of Fairmont Avenue;
  - #6- thence along the South line of Fairmont Avenue N 89 35 22 E 157.90 feet to the place of beginning containing 0.475 acres.




