7. SOUTH 42 DEGREES 12 MINUTES 25 SECONDS WEST 29.15 FEET TO AN EXISTING IRON PIN (REBAR WITH ALUMINUM CAP) AT 33 FEET LEFT OF STATION 1+00;
8. SOUTH 63 DEGREES 21 MINUTES 35 SECONDS WEST 55.24 FEET TO AN EXISTING IRON PIN (REBAR WITH ALUMINUM CAP) AT 57.22 FEET LEFT OF STATION 0+51.13 (ALSO BEING 50 FEET RIGHT OF STATION 161+48.19 OF STATE ROUTE 60);
