DESCRIPTION OF A 0.172 ACRE TRACT

Situate in the State of Ohio, County of Muskingum, City of Zanesville, and being part of the Fourth Quarter Township, Township 1 North, Range 8 West in the United States Military District and being a part of Lot # 121 (Parcel # 86-08-04-12) and part of Lot # 122 (Parcel # 86-08-04-13) of Maple Hill as recorded in Plat Book # 5, Page 63, also being all of the Michael D. and Mary Jane Bednarczuk property recorded in Volume # 1697, Page 652 of Muskingum County records and being more particularly described as follows ;

Beginning for Reference at the Intersection of the North right of way line of Somers Street (50.00 feet in width) and the West right of way line of Myrtle Avenue (50.00 feet in width), thence along the West right of way of Myrtle Avenue, North 00 degrees 00 minutes 00 seconds West 125.00 feet to a ¾" pipe found and the True Place of Beginning; thence leaving said right of way, along Brent and Robin Yarnell property (Volume 1148, Page 390) and crossing Lot # 121 , North 90 degrees 00 minutes 00 seconds West 150.00 feet to an iron pin found ; thence along an Alley 16.00 feet in width, North 00 degrees 00 minutes 00 seconds West 50.00 feet to a iron pin set , passing the northwest corner of Lot # 121 at 25.00 feet ; thence along Leonard and Peggy Glaub property (Volume 1158, Page 476), crossing Lot # 122, North 90 degrees 00 minutes 00 seconds East 150.00 feet to an axle found on the West right of way line of Myrtle Avenue ; thence along said right of way South 00 degrees 00 minutes 00 seconds West 50.00 feet to a ¾" pipe found at the True Place of Beginning, passing the southeast corner of Lot # 122 at 25.00 feet .

Containing 0.172 acres , more or less,(0.086 acres of Parcel # 86-08-04-12) and (0.086 acres of Parcel # 86-08-04-13), more or less, subject to all easements , restrictions , or right of ways , either written or implied. All iron pins set and found are # 5 rebar 30 inches long with a yellow I.D. cap labeled "BINCKLEY S - 7879" .


