## LEGAL DESCRIPTION FOR BETH MCKEE

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, CITY OF ZANESVILLE, AND BEING PART OF A 1.85 ACRE LOT (UNNUMBERED) OF KATHIE HEIGHTS #2, AS RECORDED IN PLAT BOOK #8, PAGE 67, AND BEING PART OF THOSE LANDS DESCRIBED IN DEED VOLUME 1094, PAGE 513; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF LOT #36 OF SAID KATHIE HEIGHTS SUBDIVISION, THENCE, ALONG THE SOUTH LINE THEREOF, SOUTH 88 DEGREES - 51 MINUTES - 44 SECONDS EAST, 384.93 FEET TO AN AXLE FOUND AT THE SOUTHEAST CORNER OF SAID 1.85 ACRE PARCEL; THENCE, NORTH 02 DEGREES - 36 MINUTES - 00 SECONDS EAST, 41.35 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 61 DEGREES - 45 MINUTES - 53 SECONDS WEST, 135.78 FEET TO AN IRON PIN SET; THENCE, NORTH 03 DEGREES - 12 MINUTES - 23 SECONDS EAST, 103.65 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF SOMERS STREET; THENCE, SOUTH 86 DEGREES - 47 MINUTES - 37 SECONDS EAST, 121.32 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 02 DEGREES - 36 MINUTES - 00 SECONDS WEST, 161.11 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.371 ACRES MORE OR LESS.


