

Hogue Farms, LLC OR 2381-521 Parcel 2, Tract 1 +/-54.30 Ac.

Being a part of the West Half of Lot 22, Quarter Township 2, Township 3, Range 6, Adams Township, Muskingum County, also being all of Muskingum County Parcel No. 02-40-02-04-000 now owned by Hogue Farms, LLC recorded in OR 2381-521, Parcel 2, Tract 1, at the Muskingum County Recorder more fully described as follows.

Beginning at an iron pin found at the Southeast Corner of the West Half of Lot 22, said iron pin found being the common corner of the lands now owned by said Hogue Farms, LLC, William L. & Ruby J. Lane (DR 1158-760), Douglas L. & Betty J. Yeary (OR 2119-927) and Eric L. & Shannah H. Hogue (OR 2415-459);

Thence with the south line of Lot 22, North 88 degrees 01 minutes 36 seconds West, 1309.40 feet to a point at the Southwest Corner of said Lot 22 and the Southeast Corner of the lands now owned by Hogue Farms, LLC (OR 2381-521, Parcel 1), passing an iron pin found at 749.40 feet, said point being referenced by an iron pin set which bears North 86 degrees 35 minutes 08 seconds West, 36.71 feet,;

Thence with the west line of said Lot 22 North 01 degrees 23 minutes 59 seconds East, 1992.95 feet to a point in the center of Yeary Rd. (CR-13), said point is referenced by an iron pin set which bears South 08 degrees 04 minutes 07 seconds West, 56.64 feet;

Thence with the center of said Yeary Rd. and the south line of the lands now owned by Gary A. & Lori J. Hogue (OR 1645-940) the following 3 courses:

- 1. South 63 degrees 42 minutes 22 seconds East, 81.00 feet to a point;
- 2. South 70 degrees 40 minutes 44 seconds East, 70.91 feet to a point;
- 3. South 80 degrees 38 minutes 21 seconds East, 397.82 feet to a point and the Northeast corner of the lands now owned by Hogue Farms, LLC (OR 2381-521, Parcel 4, Tract 2);

Thence leaving said center line and going with the common line of said Hogue Farms, LLC Parcel 4, Tract 2 and Parcel 2, Tract 1 the following 3 courses:

1. South 04 degrees 32 minutes 37 seconds West, 206.67 feet to a point, said point is referenced by an iron pin set which bears South 44 degrees 12 minutes 53 seconds

West, 14.18 feet;

- 2. South 85 degrees 27 minutes 23 seconds East, 157.49 feet, passing an axle found at 146.94 feet:
- 3. North 04 degrees 32 minutes 37 seconds East, 193.40 feet to a point in the center line of said Yeary Rd.

Thence with said center line the following 4 courses:

- 1. South 68 degrees 59 minutes 21 seconds East, 129.51 feet to a point;
- 2. South 62 degrees 54 minutes 13 seconds East, 372.10 feet to a point;
- 3. South 58 degrees 09 minutes 03 seconds East, 104.33 feet to a point;
- 4. South 48 degrees 49 minutes 29 seconds East, 96.33 feet to a point on the East line of the West half of Lot 22 and the common corner of the lands now own by Eli A. & Fannie J. Hostetler (OR 2440-938), Cary A. & Lori J. Hogue (DR 865-224 and Robert B. & Bobbi J. Vernon (DR 1120-282), said point is referenced by a 10" barn spike found in the center of said Yeary Rd. which bears South 38 degrees 10 minutes 39 seconds East, 22.46 feet;

Thence with said East line the West Half of Lot 22, South 01 degrees 31 minutes 29 seconds West, 1553.84 feet to the point of beginning, passing 10" barn spike found at 469.56 feet, containing 54.30 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.


