LEGAL DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Adams, and being part of the southwest quarter of Section 15 of the north half of Quarter Township 3, Township 3, Range 6, and being part of those lands intended to be described in Deed Volume 1044, page 277; being further bounded and described as follows:

Commencing at the southeast corner of the southwest quarter of said Section 15, thence, with the section line and along Bethesda Church Road (Township Road 160), north 02 degrees – 39 minutes – 40 seconds east, 633.69 feet to the **true point of beginning** for the parcel herein intended to be described:

Thence, with a new division line through those lands now or formerly owned by J. & J. Vansickle (1044/277), the following two (2) courses and distances:

1. North 86 degrees – 09 minutes – 25 seconds west, 545.59 feet to an iron pin set, passing a magnetic nail set in an eight (8) inch fence post at 31.93 feet;
2. North 07 degrees – 53 minutes – 21 seconds west, 266.19 feet to an iron pin set on the south line of those lands now or formerly owned by P. Vansickle (2154/421);

Thence, along the south line thereof, south 88 degrees – 07 minutes – 20 seconds east, 594.27 feet to a point in aforesaid Bethesda Church Road, passing an iron pin found at 574.31 feet;

Thence, south 02 degrees – 39 minutes – 40 seconds west, 281.07 feet to the **point of beginning**, and **containing 3.549 acres more or less.**

Subject to all legal highways and easements, whether recorded or implied.

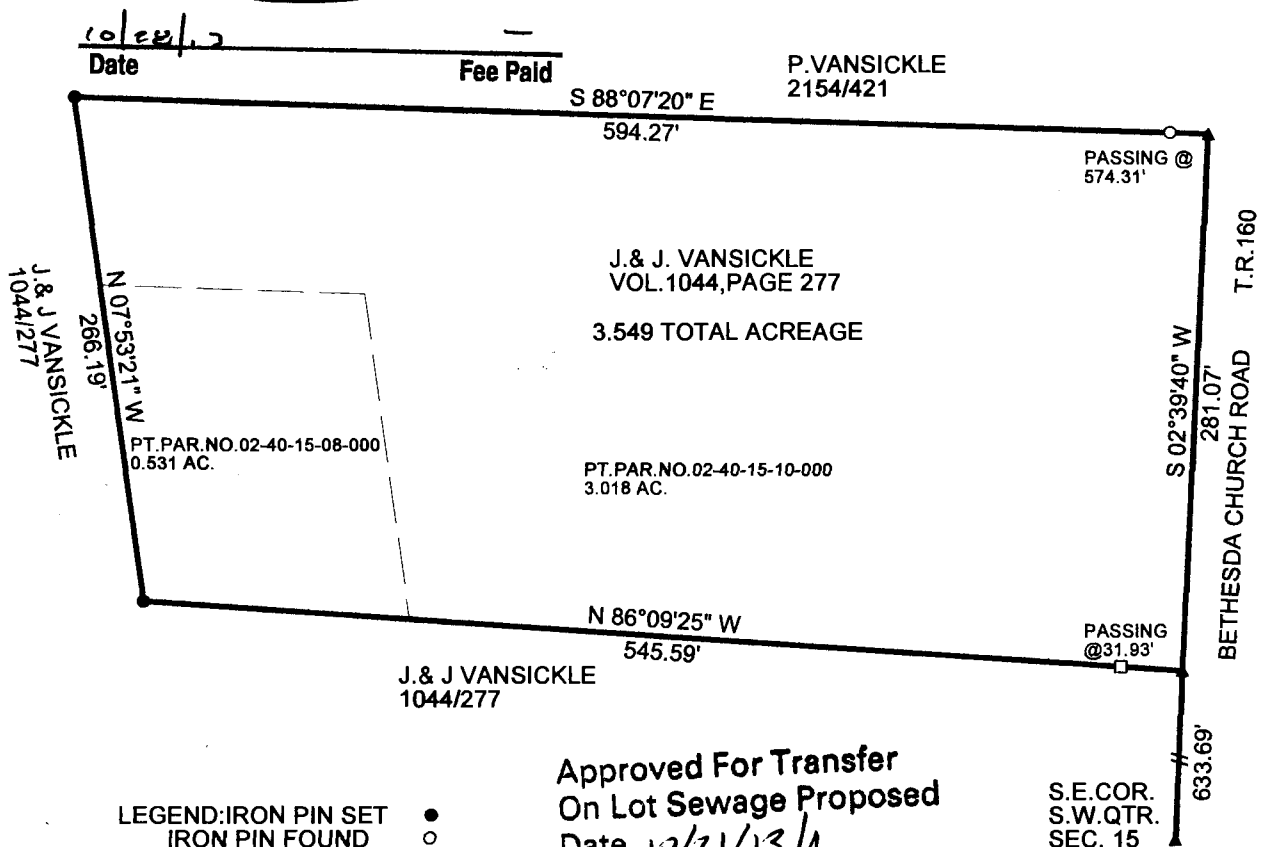
