Beginning at a 1/2 inch pipe at the Southeast Corner of the West Half of the Southeast Quarter of Section 17; thence along the South line of Section 17 South 89 Degrees 43 Minutes 18 Seconds West 397.61 feet to an iron pin set and the place of beginning; thence continuing along said line along Thomas H. York V 786 P 331 South 89 Degrees 43 Minutes 18 Seconds West 435.00 feet to a point in the existing centerline of State Route 208, passing a 1 inch iron pipe at 405.00 feet; thence along said existing centerline North 00 Degrees 35 Minutes 30 Seconds West 300.00 feet to a point in the pavement of State Route 208, passing the existing centerline of State Route 208 at 229.57; thence North 89 Degrees 43 Minutes 18 Seconds East 435.00 feet to an iron pin set, passing an iron pin set at 30.00 feet; thence South 00 Degrees 35 Minutes 30 Seconds East 300.00 feet to the place of beginning containing 3.00 acres, more or less, subject to all legal highways and easements.
