LEGAL DESCRIPTION OF A 1.005 ACRE PARCEL

Situated in the State of Ohio, County of Muskingum, Township of Adams, and being a part of the Southwest Quarter of Section 17, Township-3N, Range-6W, and being a survey of part of that tract as conveyed to Robert and Lou Ann Tilton (Auditors Parcel No. 02-40-17-11-000), by deed of record in Deed Volume 904, Page 362, all references being to those of record in the Muskingum County Recorder's Office, said 1.005 acre parcel being further described as follows:

Beginning for reference at an existing stone marking the Northeast corner of the Southwest Quarter of Section 17:

thence southwesterly along the easterly line of said Tilton tract, **South 01°26'08" West, 358.90 feet** to an existing iron pin (axle):

thence northwesterly, **North 89°32'42" West, 206.93 feet** to an existing iron pin (axle):

thence southwesterly along the easterly line of said Tilton tract, **South 01°27'54" West, 1668.74 feet** to a point on the North edge of pavement of State Route 208, also known as Dresden/Adamsville Road, passing an existing iron pin (3/4" square rod) at **1647.74 feet**;

thence northwesterly along the north edge of pavement of said State Route 208 the following two (2) courses and distances:

North 89°16'04" West, 695.26 feet to a point:

North 86°09'17" West, 51.16 feet to a point and being the southeasterly corner and the **True Point of Beginning** of the hereon described 1.005 acre parcel;

thence northwesterly continuing along the north edge of pavement, **North 86°09'17" West, 178.00 feet** to a point;

thence leaving the north edge of pavement and with what represents new lines through said Tilton tract the following three (3) courses and distances;

North 06°06'07" East, 242.98 feet to an iron pin set, passing an iron pin set at **13.00 feet**;

South 88°15'02" East, 178.38 feet to an iron pin set; and..

South 06°06'07" West, 249.51 feet to the True Point of Beginning, and containing 1.005 acres more or less according to a survey performed by Graham Surveying in July, 1999, passing an iron pin set 236.40 feet.

Bearings in the above described 1.005 acre parcel are based on the North line of the Southwest Quarter of Section 17 as being South 86°57'44" East as referenced in Deed Volume 904, Page 362.

All iron pins set are 5/8" in diameter by 30" in length rebars with yellow surveyors caps marked "Graham, 7952".

This survey was prepared without the benefit of a title policy, there may be easements or rights-of-ways which apply.

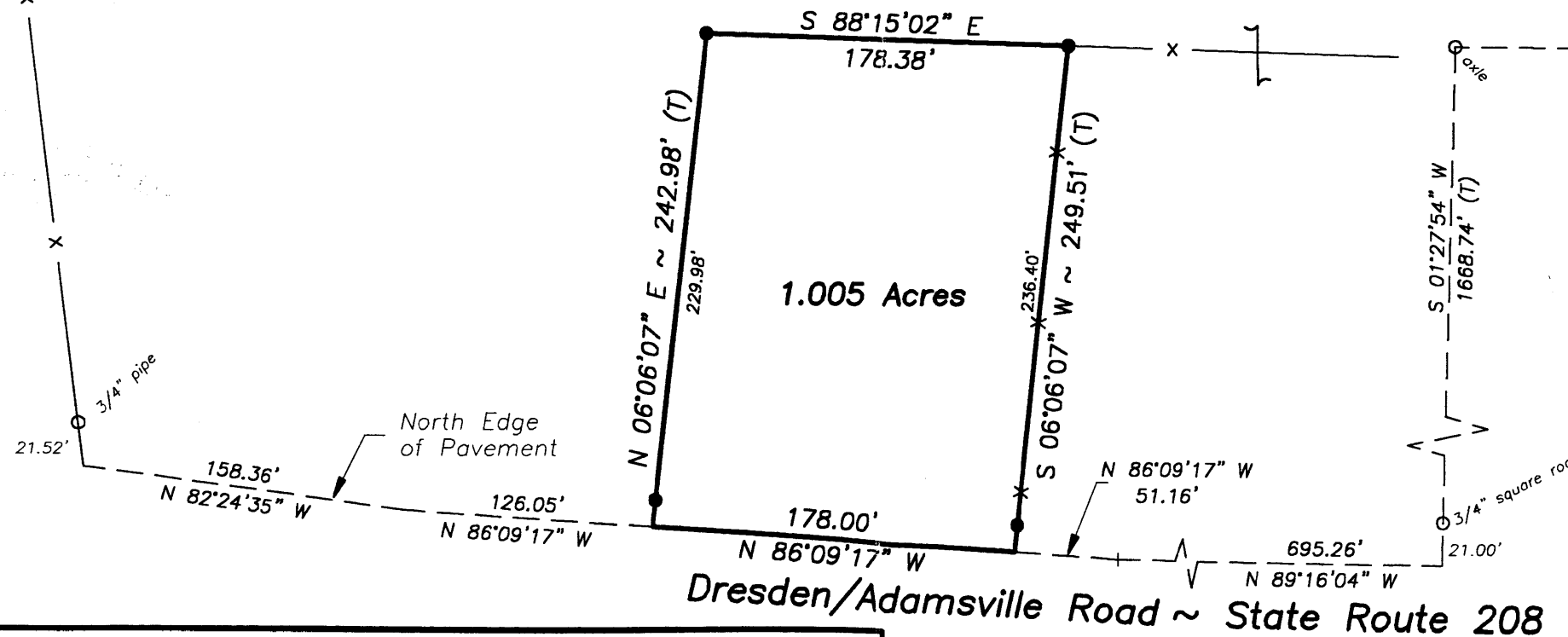

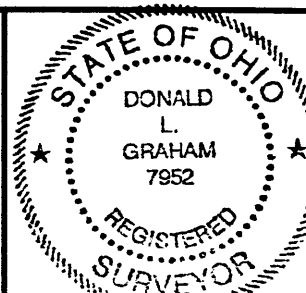
