Commencing at a point at the intersection of the South line of a tract owned by Leah Zinsmeister as recorded in Deed Volume 524 at Page 245 of the Muskingum County Records and the center line of State Route Sixty, said point being Station 112+79 of State Route 60; thence North 14 degrees 48 minutes 00 seconds west 1056.88 feet to a point in the centerline of State Route 60, said point being the place of beginning of this tract; thence South 86 degrees 58 minutes 57 seconds West 420.07 feet to a point marked by an iron pin, passing a point marked by an iron pin at 49.00 feet; thence South 82 degrees 14 minutes 32 seconds West 94.06 feet to a point marked by an iron pin; thence North 89 degrees 02 minutes 03 seconds West 14.90 feet to a point marked by an iron pin; thence South 89 degrees 41 minutes 02 seconds West 320.98 feet to a point on the East Bank of the Muskingum River, passing a point marked by an iron pin at 307.33 feet; thence North 03 degrees 34 minutes 15 seconds West 159.24 feet to a point on the East Bank of the Muskingum River; thence North 89 degrees 41 minutes 02 seconds East 824.76 feet to a point in the center of State Route 60, passing points marked by iron pins at 18.00 feet and 722.95 feet; thence South 14 degrees 48 minutes 00 seconds East 131.57 feet to the place of beginning.


