TYSINGER AS RECORDED IN DEED BOOK VOLUME 881, PAGE 172 OF THE MUSKINGUM COUNTY DEED RECORDS, SITUATED IN THE NORTHEAST QUARTER OF SECTION 5, TOWNSHIP 12, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, BLUE ROCK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A POINT MARKED BY AN EXISTING IRON PIN (3/4 INCH I. D. PIPE) AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 5;

THENCE NORTH 00 DEGREES 32 MINUTES 48 SECONDS WEST 478.40 FEET ALONG THE EAST LINE OF THE SAID NORTHEAST QUARTER TO A POINT MARKED BY AN EXISTING IRON PIN (3/4 INCH I. D. PIPE);

THENCE NORTH 89 DEGREES 57 MINUTES 57 SECONDS WEST 2937.46 FEET ALONG THE NORTH LINE OF THE ABOVE MENTIONED 162.639 MORE OR LESS ACRE TRACT TO A POINT MARKED BY AN EXISTING IRON PIN (5/8 INCH REBAR), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE LEAVING SAID NORTH LINE AND TRAVERSING THROUGH SAID TYSINGER TRACT THE NEXT 4 COURSES AND DISTANCE:

- 1) SOUTH 41 DEGREES 11 MINUTES 41 SECONDS EAST 84.08 FEET TO AN IRON PIN SET;
- 2) SOUTH 03 DEGREES 46 MINUTES 03 SECONDS EAST 143.47 FEET TO AN IRON PIN SET;
- 3) SOUTH 81 DEGREES 12 MINUTES 59 SECONDS WEST 158.32 FEET TO AN IRON PIN SET;
- 4) NORTH 24 DEGREES 07 MINUTES 41 SECONDS WEST 94.06 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF 1.000 MORE OR LESS ACRE TRACT CONVEYED TO JERRY TYSINGER BY DEED RECORDED IN VOLUME 999, PAGE 13 OF THE MUSKINGUM COUNTY DEED RECORDS;

THENCE WITH THE SAID SOUTH LINE, SOUTH 89 DEGREES 57 MINUTES 57 SECONDS EAST 169.06 FEET TO A POINT ON THE SOUTHEAST CORNER OF SAID JERRY TYSINGER TRACT;

THENCE WITH THE EAST LINE OF SAID JERRY TYSINGER TRACT NORTH 15 DEGREES 02 MINUTES 59 SECONDS WEST 150.00 FEET TO THE PLACE OF BEGINNING.

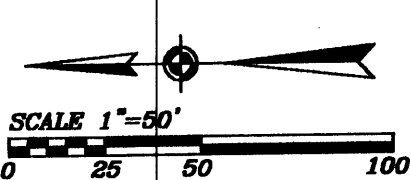

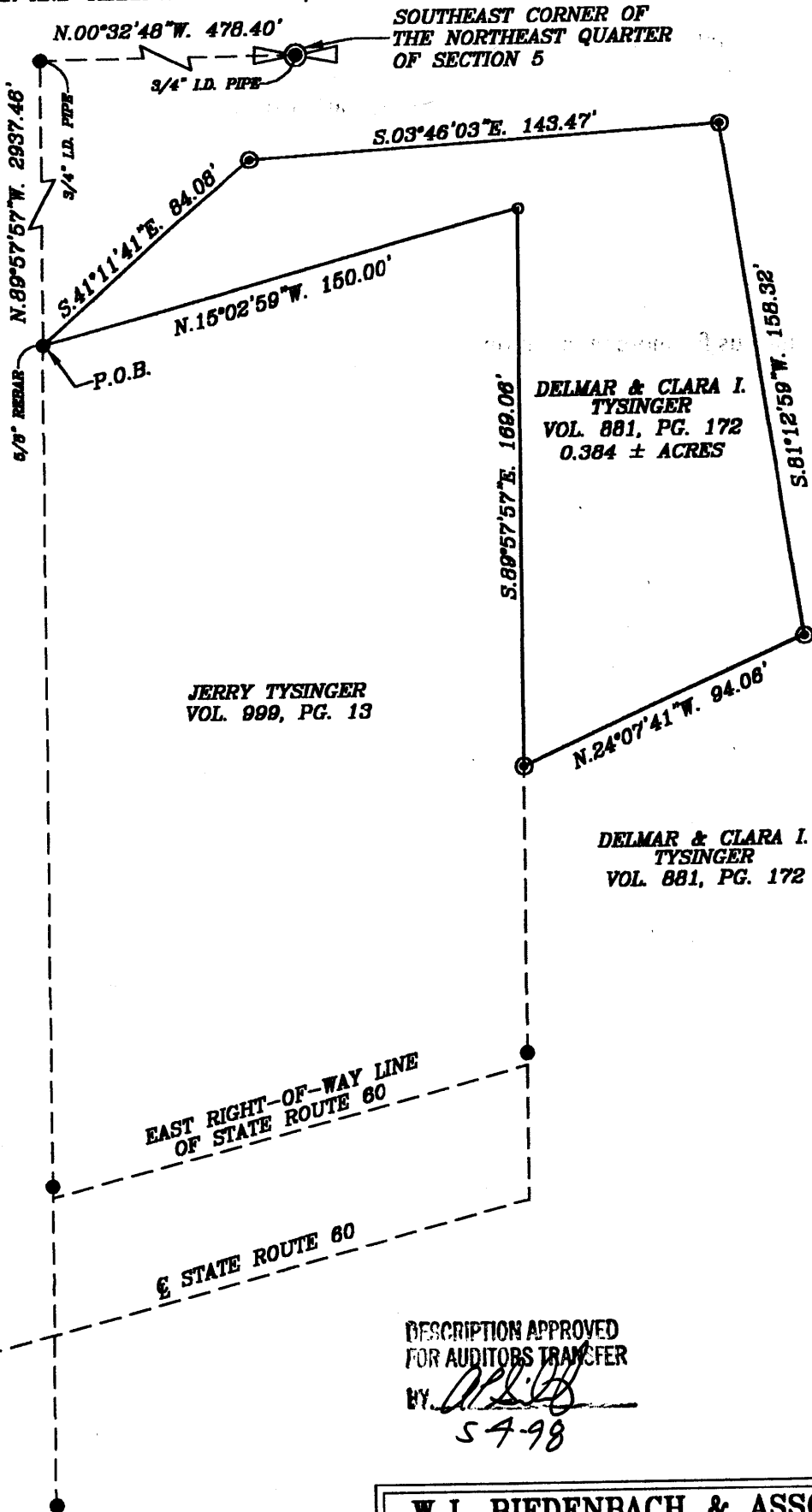
