BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 8, TOWNSHIP 12, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, BLUE ROCK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE SOUTHEAST CORNER OF LOT NUMBER 18 OF PIONEER ACRES AS RECORDED IN PLAT BOOK 11, PAGE 14 OF THE MUSKINGUM COUNTY PLAT RECORDS; THENCE ALONG THE WEST LINE OF PIONEER DRIVE NORTH 32 DEGREES 10 MINUTES 00 SECONDS WEST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 1530.64 FEET A TOTAL DISTANCE OF 1715.72 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING NORTH 32 DEGREES 10 MINUTES 00 SECONDS WEST 3.30 FEET TO AN IRON PIN SET AT THE NORTHEAST CORNER OF LOT NUMBER 1 OF SAID PIONEER ACRES AND THE SOUTH LINE OF A TRACT CONVEYED TO P. PYLES AS RECORDED IN DEED VOLUME 675, PAGE 333 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE LEAVING SAID LOT NUMBER 1 AND ALONG THE SOUTH LINES OF SAID PYLES TRACT NORTH 33 DEGREES 51 MINUTES 00 SECONDS EAST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 17.17 FEET, A TOTAL DISTANCE OF 320.55 FEET TO AN IRON PIN SET; THENCE NORTH 01 DEGREES 55 MINUTES 01 SECONDS EAST 234.56 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE); THENCE NORTH 87 DEGREES 45 MINUTES 48 SECONDS EAST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 420.39 FEET, A TOTAL DISTANCE OF 460.39 FEET TO A POINT IN THE CENTER OF S.R. 60; THENCE LEAVING SAID PYLES TRACT AND ALONG THE CENTER OF SAID S.R. 60 SOUTH 11 DEGREES 50 MINUTES 11 SECONDS EAST 32.95 FEET TO A POINT IN SAID CENTER; THENCE LEAVING SAID CENTER AND ALONG THE NORTH LINE OF PIONEER DRIVE THE NEXT THREE COURSES AND DISTANCES:

- 1) SOUTH 78 DEGREES 09 MINUTES 00 SECONDS WEST, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 30.00 FEET A TOTAL DISTANCE OF 272.30 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE),
- 2) WITH A CURVE TO THE LEFT HAVING A RADIUS OF 275.66 FEET (CHORD BEARING SOUTH 56 DEGREES 00 MINUTES 00 SECONDS WEST 207.87 FEET) AN ARC DISTANCE OF 213.14 FEET TO AN IRON PIN SET,
- 3) SOUTH 33 DEGREES 51 MINUTES 00 SECONDS WEST 381.70 FEET TO THE PLACE OF BEGINNING.

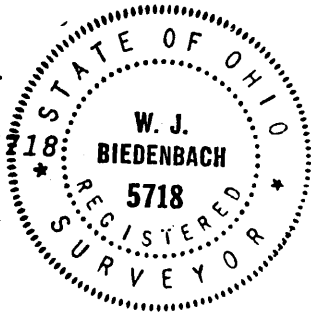
