Iron pins set are No. 5 reinforcing bars 30 inches long with plastic I. D. caps.

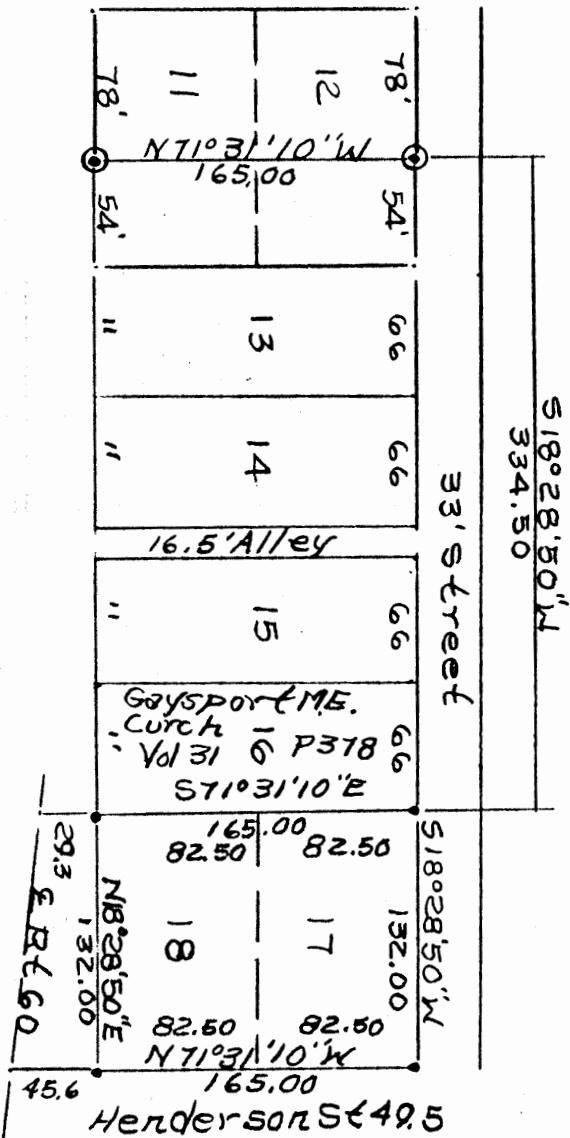
