COMMENCING AT THE SOUTHEAST CORNER OF LOT NUMBER 26 OF THE VILLAGE OF GAYSPORT (DEED BOOK 17 PAGE 433); THENCE NORTH 56 DEGREES 35 MINUTES 38 SECONDS WEST 30.00 FEET ALONG THE SOUTH LINE OF SAID LOT TO A POINT; THENCE SOUTH 33 DEGREES 24 MINUTES 22 SECONDS WEST 691.50 FEET TO THE SOUTHWEST CORNER OF A 8.503 MORE OR LESS ACRE TRACT CONVEYED IN DEED BOOK VOLUME 939, PAGE 9 OF THE MUSKINGUM COUNTY DEED RECORDS, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 16.50 FEET; THENCE SOUTH 33 DEGREES 53 MINUTES 25 SECONDS WEST 1081.84 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE NORTHWEST CORNER OF LOT NUMBER 1 OF THE SAID UNRECORDED PLAT; THENCE SOUTH 39 DEGREES 56 MINUTES 10 SECONDS WEST 805.00 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE) AT THE NORTHWEST CORNER OF SAID LOT NUMBER 9, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THIS TRACT; THENCE SOUTH 56 DEGREES 30 MINUTES 00 SECONDS EAST 790.59 FEET ALONG THE NORTH LINE OF SAID LOT NUMBER 9 TO AN IRON PIN SET, PASSING AN EXISTING IRON PIN (3/4 INCH PIPE) AT 99.01 FEET; THENCE SOUTH 28 DEGREES 26 MINUTES 58 SECONDS WEST 161.05 FEET TO AN IRON PIN SET; THENCE NORTH 86 DEGREES 30 MINUTES 00 SECONDS WEST 79.32 FEET TO AN EXISTING IRON PIN (1/2 INCH PIPE) ON THE SOUTH LINE OF LOT NUMBER 10; THENCE NORTH 56 DEGREES 30 MINUTES 00 SECONDS WEST 770.37 FEET TO AN IRON PIN SET, PASSING EXISTING IRON PINS AT 116.62 FEET (1/2 INCH PIPE), 298.95 FEET (1/2 INCH PIPE), 419.62 FEET (1/2 INCH PIPE) AND 609.52 FEET (3/4 INCH PIPE); THENCE NORTH 43 DEGREES 11 MINUTES 38 SECONDS EAST 101.50 FEET TO AN EXISTING IRON PIN (3/4 INCH PIPE); THENCE NORTH 43 DEGREES 15 MINUTES 38 SECONDS EAST 101.50 FEET TO THE PLACE OF BEGINNING.

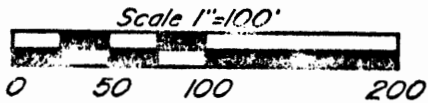
