SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF BLUE ROCK AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 20, TOWNSHIP 12, RANGE 12, AND BEING PART OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1106, PAGE 432; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF LOT #26 OF THE VILLAGE OF GAYSPORT, AS RECORDED IN DEED BOOK 17, PAGE 433, THENCE, SOUTH 33 DEGREES - 40 MINUTES - 21 SECONDS WEST, 1073.28 ALONG THE EASTERLY RIGHT-OF-WAY OF STATE ROUTE 60 TO AN IRON PIN FOUND; THENCE, SOUTH 34 DEGREES - 00 MINUTES - 48 SECONDS WEST, 100.00 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

THENCE, SOUTH 56 DEGREES - 34 MINUTES - 19 SECONDS EAST, 756.26 FEET TO AN IRON PIN SET;

THENCE, SOUTH 23 DEGREES - 17 MINUTES - 40 SECONDS WEST, 304.71 FEET TO AN IRON PIN FOUND;

THENCE, NORTH 56 DEGREES - 32 MINUTES - 45 SECONDS WEST, 812.93 FEET TO AN IRON PIN FOUND ON THE EASTERLY RIGHT-OF-WAY OF STATE ROUTE 60;

THENCE, NORTH 34 DEGREES - 00 MINUTES - 48 SECONDS EAST, 299.60 FEET TO THE POINT OF BEGINNING, AND CONTAINING 5.3994 ACRES MORE OR LESS.

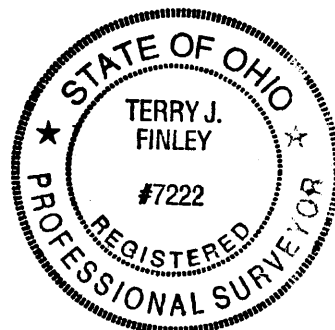
IRON PINS SET ARE 5/8" REBAR WITH YELLOW IDENTIFICATION CAP (FINLEY S-7222).

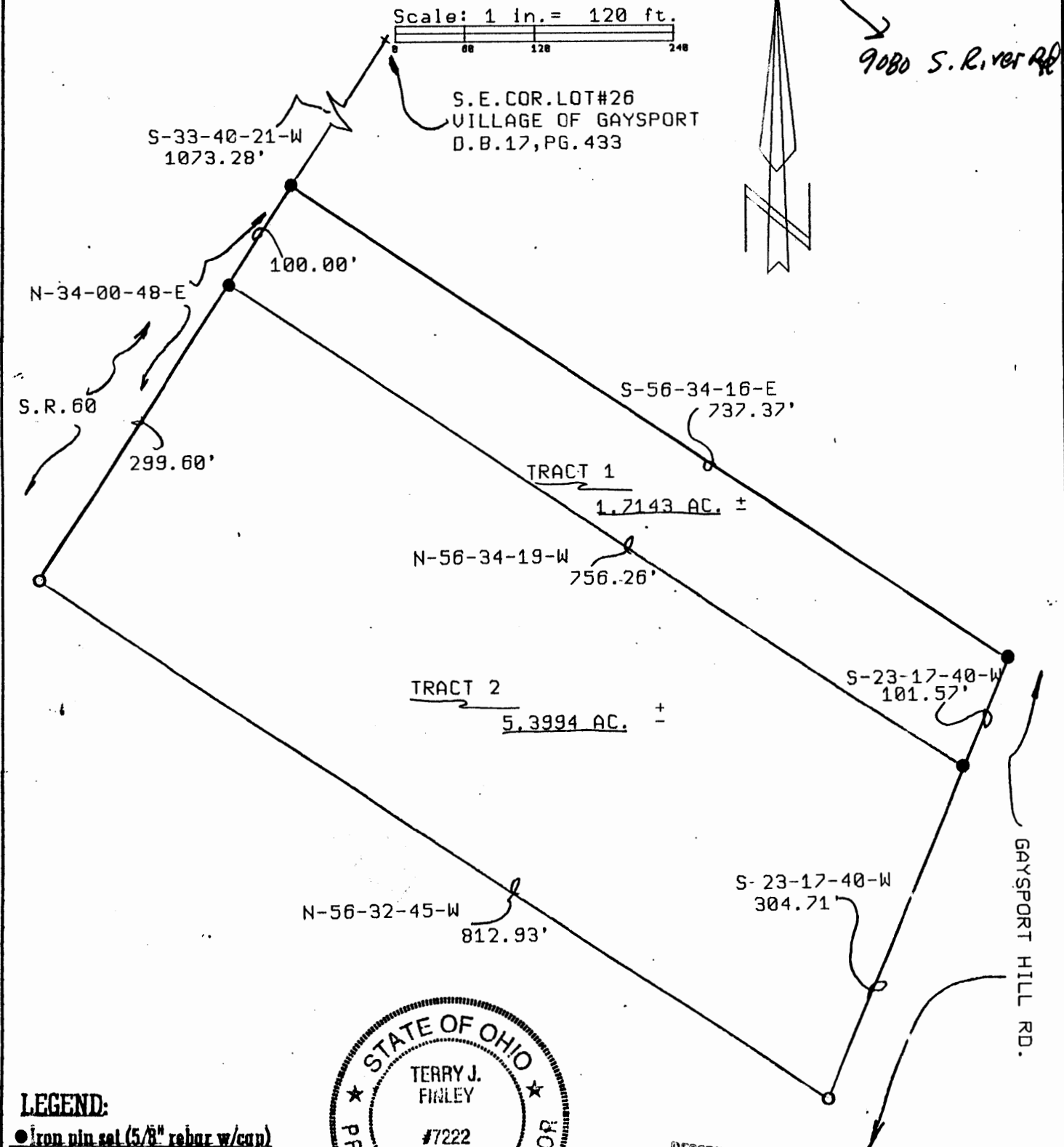
